Comes now the Staff of the Florida Public Service Commission (Commission Staff), by and through its undersigned counsel, and files this Motion for Extension of Time to File Testimony, and in support thereof states:

1. The testimony of the Commission Staff was required to be filed on January 25, 2005, pursuant to Order No. PSC-04-1217-PCO-WS, issued December 9, 2004. That Order also required rebuttal testimony to be filed on February 15, 2005.

2. However, due to a personal illness, staff's witness was unavailable from January 17-24, 2005. Therefore, staff requests that it be granted a two-day extension in which to file its testimony.

3. Staff has contacted Aloha Utilities, Inc. and the Office of Public Counsel, the other parties who have filed testimony in this docket, and they state that with a corresponding extension for the filing of rebuttal testimony, that they have no objection to the granting of a two-day extension.

4. Therefore, staff requests that its testimony now be due on January 27, 2005, and that rebuttal testimony be due on February 17, 2005.
