The parties are advised that a conference call has been scheduled with the Prehearing Officer in this proceeding to discuss the propriety of continuing to include Issue 17(e) in this proceeding. In preparation for the call, parties are advised that they should plan to address the administrative, as well as legal, reasons for including (or excluding) this issue from the proceeding. Parties are further directed to be prepared to address the impact, if any, of the stipulation approved by Order PSC-03-0761-PAA-TP, issued June 25, 2003, in Docket No. 000121C on whether Issue 17(e), or any portion of Issue 17, should be included in this proceeding. In the context of that discussion, the parties should also be prepared to discuss the Joint Motion for Adoption of Amendments to Joint Partial Settlement Agreement Pursuant to Article 13.5 of the Commission's Rules of Practice and Procedure, which is currently pending before the California Commission. If the parties to this Florida proceeding have not yet discussed the impact of the proposed Stipulation in California, the Prehearing Officer strongly suggests that such discussion take place prior to the conference call.
