It is a mult-step process. The first step is transfer from NuVox to NewSouth and the name would change to NewSouth (whether or not NewSouth would be a different company code, we in CMP are not sure - but we believe it would be). The second step, it would then tranfer to NuVox and the name would change from NewSouth to NuVox. From a practical standpoint, the middle step was only done to satisfy some legal/technical requirement of the requestor. Ultimately, the final name would be the same as the original name on the certificate. The final NuVox name would, however, be a different company code from the original NuVox company because the original NuVox company went out of business and a new company with the same name was formed.

I didn't have anything to do with that. The PSC Consent template gave me two choices - transfer and name change or transfer of control. I felt transfer and name change was more appropriate.


