Staff Counsel has recently brought to my attention an error in the Joint Petition filed in this proceeding by Central Florida Electric Cooperative and Progress Energy Florida on December 17, 2004. On page 3, paragraph 5 of that pleading, the number of customers to transferred from Central Florida to Progress Energy and from Progress Energy to Central Florida were transposed.

Accordingly, I have enclosed for filing on behalf of Joint Petitioners a corrected page 3 to their Joint Petition in which the revised customer numbers have been highlighted.

Exhibit A to the Amended Agreement, official General Highway County maps for Levy and Marion Counties depicting the Territorial Boundary Line are appended hereto as Attachment 2.

5. The Amended Agreement provides for the transfer of all Extra-Territorial Customers to the party in whose service territory such customers are located. The parties expect that all such transfers and related service facilities will be completed within 36 months of the Commission's order approving the Amended Agreement. The parties are agreeable to submitting annual reports on the status of these customer and related facilities transfers if that is the Commission's desire, and will provide the Commission advance notification if extenuating circumstances require additional time to complete the transfers. The names and service addresses of the Extra-Territorial Customers subject to transfer are listed in Exhibit B to the Amended Agreement, which includes 190 customers to be transferred from Central Florida to Progress Energy and seven customers to be transferred from Progress Energy to Central Florida.

6. Prior to the filing of this Joint Petition, all Extra-Territorial Customers subject to transfer have been sent written notification of the Amended Agreement between Central Florida and Progress Energy, the transfer provisions described above, the necessity of Commission approval, and their opportunity to be heard in this regard. A sample copy of the letter providing such notification to the affected Extra-Territorial Customers is appended hereto as Attachment 3. As of the time of filing, no responses to the notification letter have been received. A summary
