**BELLSOUTH TELECOMMUNICATIONS, INC.'S AND
XO COMMUNICATIONS SERVICES, INC.'S JOINT MOTION
FOR EXTENSION OF TIME TO FILE SUPPLEMENTAL
REBUTTAL TESTIMONY**

BellSouth Telecommunications, Inc. (BellSouth) and XO Communications Services, Inc. (XO) (jointly, the Parties), pursuant to rule 28-106.204, Florida Administrative Code, file this Joint Motion for Extension of Time to File Rebuttal Testimony until April 28, 2005. As grounds therefore, the Parties state:

1. On March 1, 2005, the Parties filed a Joint Motion for Continuance in this matter in which they requested that the hearing be continued to allow them to conduct discovery limited to the appropriate amount of a true-up, if any, and the circuits to which such true-up should apply, if any. This request was granted in Order No. PSC-05-0274-PCO-TP and the hearing was rescheduled for May 19, 2005.

2. Subsequently, the Parties filed a Joint Motion to Amend the Order on Procedure and Prehearing Order and requested permission to add Issue 4 to this proceeding and to file supplemental direct and rebuttal testimony on Issue 4. This Motion was granted in Order No. PSC-05-0337-PCO-TP (Amended Procedural Order). The Amended Procedural Order set dates for the filing of supplemental direct (April 8) and supplemental rebuttal testimony (April 21).

3. The Parties filed Supplemental Direct testimony on April 8, 2005. However, the Parties' testimony contains a great deal of data which must be reviewed,

analyzed and verified before meaningful rebuttal testimony can be filed. Therefore, the Parties request a one-week extension of time, or until April 28, 2005, to file their supplemental rebuttal testimony.

4. The Amended Procedural Order also sets May 10, 2005 as the cut off date for discovery in this case. To accommodate the requested extension for rebuttal testimony, the Parties also request that the discovery deadline be extended to May 16, 2005 so that discovery can be conducted as to the supplemental rebuttal testimony. The 10-day turn around time for such discovery responses will remain in place.

WHEREFORE, the Parties request that the Commission enter an Order granting a one-week extension of time for supplemental rebuttal testimony until April 28, 2005 and that the Order extend the cut-off date for discovery to May 16, 2005.
