On April 4, 2005, the Commission received the attached letter dated March 21, 2005, from Mr. You Iv, Secretary for 224 Express, Inc., a certificated pay telephone company requesting a refund in the amount of \$300.98. Although 224 Express, Inc. is entitled to a refund, the correct amount is \$116.93. The following shows how the Division of Competitive Markets & Enforcement (CMP) came to this determination.

#### 2001

224 Express, Inc. believes it should only have paid the Regulatory Assessment Fee of \$0.37 based on revenues in the amount of \$245.

CMP has determined that on 01/08/02, the company reported revenues in the amount of \$245 and sent in a check for \$36.75. Since the company did not pay the \$50 minimum, there was a balance of \$13.25. On 07/02/02, the company paid the balance of \$13.25 plus the \$3.31 penalty and \$0.80 interest on the balance. The 2001 Regulatory Assessment Fee is paid in full and the company is not due a refund.

224 Express, Inc. believes it should only have paid the Regulatory Assessment Fee of \$1.03 based on revenues in the amount of \$682.

CMP has determined that on 01/26/04, the company reported revenues in the amount of \$682 and sent in a check for \$102. The company should have paid the \$50 minimum, leaving a credit of \$52. CMP staff believes the company is due a refund of \$52 for the 2003 Regulatory Assessment Fee.

#### 2004

224 Express, Inc. believes it should only have paid the Regulatory Assessment Fee of \$0.85 based on revenues in the amount of \$563.40.

CMP has determined that on 01/24/05, the company reported revenues in the amount of \$563.40 and sent in a check for \$84.45. The company should have paid the \$50 minimum, leaving a credit of \$34.45. CMP staff believes the company is due a refund of \$34.45 for the 2004 Regulatory Assessment Fee.

Based on the above, we believe the company is entitled to a refund in the amount of \$116.93 for overpayments of the 2002, 2003, and 2004 Regulatory Assessment Fees. Please send 224 Express, Inc. a refund form in the amount of \$116.93, along with a copy of this Memorandum, so that the company can see how staff came to this determination.
