On March 31, 2005, the Department received information concerning the application for Original Certificate to supply sanitary sewer and potable water services in Sumter County, by Central Sumter Utility Company, L.L.C. Pursuant to the Memorandum of Understanding between the Public Service Commission (PSC) and the Department of Community Affairs, the Department has agreed to review applications for new or revised service and provide comment on the need for service and comprehensive plan consistency. The Department has completed its review and offers the following comments:

Based on our review, the new proposed service territory of Central Sumter Utility, L.L.C. appears to be consistent with the Sumter County comprehensive plan. The proposed service areas are designated Mixed Use land use and lie within the Villages of Sumter Development of Regional Impact. The Mixed Use land use allows a maximum residential density of 5.4 dwelling units per net residential acre. The Department does not object to the proposed service territory to provide sanitary sewer and potable water services to The Villages of Sumter Development of Regional Impact.
