

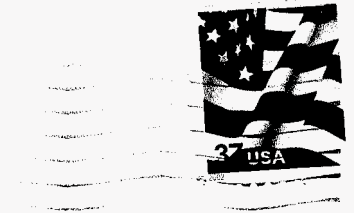

This Commission has received your company's application for a Pay Telephone Service (PATs) Certificate of Public Convenience and Necessity. In answering questions 13, and 14, you neglected to list your Vice President, Jesus Sole's previous relationship with Advanced Payphones U.S.A., Inc. Please amend your Pay Telephone Service's application and submit it to my attention.

According to our records, Advanced Payphones U.S.A., Inc.'s PATs certificate was cancelled in Docket No. 020797-TC for violation of Rule 25-4.0161, F.A.C., Regulatory Assessment Fees; and 25-24.520, F.A.C., Reporting Requirements.

Staff requests that you explain why granting Speed Power Communications, Inc. a certificate, given Mr. Sole's past history, would be in the public interest. If we do not receive a response in writing by April 29, 2005, we will assume that you no longer want to pursue certification and we will recommend that the PATs certificate application be denied and the docket closed.
