
Dear Ms. Bayó:

BellSouth is writing this letter in response to the Commission staff's request in the status conference held on May 23, 2005. Specifically, staff asked when BellSouth notified CLECs of the modifications to interconnection agreements necessitated by certain changes in law. BellSouth provided CLECs written notice of such changes during the timeframes below:

Triennial Review Order:	Notice was issued between 10/17/03 -10/30/03
USTA II:	Notice was issued between 6/30/04 – 7/15/04
FCC Interim Rules:	Notice was issued between 9/22/04 – 9/30/04
Triennial Review Remand:	Notice was issued between 3/14/05 – 3/18/05

Staff also requested that BellSouth provide a draft Notice that would alert CLECs to the existence of this docket. Enclosed is such a draft Notice. I trust this letter responds to staff's needs.

**NOTICE OF PENDING DOCKET**

On or about November 1, 2004, BellSouth Telecommunications, Inc. filed with the Florida Public Service Commission its Petition to establish generic docket to consider amendments to interconnection agreements resulting from changes of law. BellSouth's petition seeks to require the amendment of existing interconnection agreements to effectuate the FCC's *Triennial Review Order* and the FCC's *Triennial Review Remand Order* and to resolve any disputes arising out of such orders that may be raised in pending negotiations or arbitrations. Based on a determination that the outcome of this docket will impact all Florida CLECs with existing or pending interconnection agreements with BellSouth Telecommunications, Inc., each Florida CLEC is hereby notified of this pending docket. 
