ORDER CLOSING DOCKET

BY THE COMMISSION:

In Docket No. 991377-TL, <u>Initiation of show cause proceedings against Sprint-Florida</u>, <u>Incorporated for violation of service standards</u>, by Order No. PSC-00-2462-PAA-TL, issued December 20, 2000, we approved the Service Guarantee Plan (SGP) submitted by Sprint-Florida, Incorporated (Sprint). Sprint's original SGP was implemented on June 1, 2001, and terminated on May 31, 2003.

In this docket, on May 7, 2003, Sprint filed a Petition for a two year extension of the limited waiver of Rules 25-4.066(2), 25-4.070(3)(a), 25-4.073(1)(c) and (1)(d), and 25-4.110(2)¹, Florida Administrative Code (F.A.C.); and for approval of modification and extension of its SGP. By Order No. PSC-03-0733-PAA-TL, issued June 19, 2003, we approved Sprint's Petition. Sprint's current SGP is scheduled to expire on May 31, 2005.

On May 11, 2005, Sprint filed a letter seeking our approval for a three month extension of its current SGP. In its letter, Sprint stated it will file a Petition with this Commission by July 15, 2005, requesting approval of a revised SGP, pursuant to Rule 25-4.085, Florida Administrative Code. Sprint further stated that its customers will continue to receive any applicable credits offered under the current SGP during the three month extension. Sprint's request proposes the new termination date for its current SGP would be August 31, 2005.

We are vested with jurisdiction over this matter pursuant to Sections 120.542, 364.01, 364.03, 364.17, and 364.183, Florida Statutes. Accordingly, we extend the time period of Sprint-Florida, Incorporated's current Service Guarantee Plan and limited waiver of Rules 25-4.066(2), 25-4.070(3)(a), 25-4.073(1)(c) and (1)(d), and 25-4.110(6), Florida Administrative Code, for an additional 3 months.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the time period of Sprint-Florida, Incorporated's current Service Guarantee Plan and limited waiver of Rules 25-4.066(2), 25-4.070(3)(a), 25-4.073(1)(c) and (1)(d), and 25-4.110(6), Florida Administrative Code, is hereby extended for an additional 3 months, ending August 31, 2005. It is further

ORDERED that this Docket shall be closed. Thereafter, upon Sprint's filing of a revised SGP, a new Docket shall be opened to address such filing.

This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
