Staff's discussion on Issue No. 3 suggests that the parties are in the best position to negotiate terms for a true-up mechanism. FDN and BellSouth Telecommunications, Inc. (BellSouth) have discussed possible resolution of the matters addressed in the staff recommendation; however, it is FDN's belief that a deferral of more than one agenda would be needed to effectively conclude such negotiations. Therefore, we request a deferral to an Agenda Conference in July.

FDN has contacted BellSouth regarding this request but has not yet received a response. We are filing this letter now to allow the Commission sufficient time to process the deferral request.
