The indented paragraph below is the paragraph we plan to include on the revised tariff. As you can see, it is your proposed paragraph with one additional sentence, in italics, to indicate that any customer that incurs excessive consumption will receive a written explanation of the additional charges:

In accordance with the City of Largo Ordinance No. 2004-57, if a customer exceeds allowed water consumption during the bi-monthly billing cycle affecting an increase in the normal sewer fee, the customer will be billed by the utility for the increase in wastewater fee upon receipt of the statement. *The utility will provide a written explanation of the additional charges to any customer that is billed for excessive water consumption.*

Please review the additional sentence and let me know in writing (a simple fax is fine) if you agree with the language.

We will be filing the staff recommendation for the tariff revision on July 7. When it is filed, I will send you a copy.
