

**BELLSOUTH'S PROPOSED ISSUES LIST**

Currently pending before the Florida Public Service Commission ("Commission") is BellSouth Telecommunications, Inc.'s ("BellSouth") motion to dismiss the petition filed by Florida Digital Network, Inc. ("FDN") protesting Proposed Agency Action Order No. PSC-05-0488-PAA-TP, issued May 5, 2005 ("*PAA Order*"), and requesting a formal proceeding in this matter ("FDN Protest"). In the *PAA Order*, the Commission approved a revised performance assessment plan for BellSouth ("revised SQM/SEEM plan") that had been agreed to by BellSouth and a coalition of CLECs. The revised SQM/SEEM plan was filed in this docket on April 18, 2005, and is the end product of an exhaustive periodic review of the current SQM/SEEM plan that the Commission Staff ("Staff") commenced in July 2004 and concluded in April 2005. As requested by Staff, and in the event that the Commission denies BellSouth's motion to dismiss, BellSouth submits the following proposed issues list.

1. Should the revised SQM/SEEM plan contained in Order No. PSC-05-0488-PAA-TP, issued on May 5, 2005, be approved by the Commission?
