Dear Ms. Relvini:

I apologize for the misunderstanding. I will send you the 2004 Regulatory Assessment Fee (RAF) returns for both the IXC and CLEC certificates via separate e-mails.

If you wish to cancel the IXC Registration in Docket No. 040935-TI, please replace the following paragraph in your settlement letter:

"Enclosed are the company's 2003 and 2004 Regulatory Assessment Fee returns, along with full payment for the fees, including late payment charges for the years 2002 and 2003. To resolve this docket, the company respectfully requests that the Commission accept its proposal to voluntarily cancel its registration in lieu of the \$500 fine imposed."

Since there is not currently a docket pending against the company's CLEC Certificate (TX545), the company just needs to pay the outstanding late fees of \$7.09 for late payment of the 2002 fee plus the 2004 Regulatory Assessment Fee. The company should include a letter requesting cancellation of the CLEC certificate, include the reason why (such as no longer in business or never started operations), state that the company has no customers (if this is a true statement), and include the 2004 RAF return, along with full payment. A docket will then be established to grant the company a voluntary cancellation. If we receive this separate letter by December 31, 2004, then the company will not be responsible for the 2005 fee. As information, if a certificate is active for any portion of a calendar year, the fee is owed for that year.
