NOTICE OF BAR DATE TO FILE REQUESTS FOR CHAPTER 11 ADMINISTRATIVE CLAIMS

PLEASE TAKE NOTICE that, at the request of Gary F. Seitz, the Chapter 11 Trustee of the above-captioned estates, the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") has entered an Order establishing September 16, 2005 (the "Administrative Bar Date"), as the last date to file requests for the purpose of asserting chapter 11 administrative claims pursuant to section 503 of chapter 11 of title 11 of the United States Code against e.Spire Communications, Inc., et al.
