Trinsic Communications, Inc. ("Trinsic") and BellSouth Telecommunications Inc. hereby move to withdraw items pending before the Florida Public Service Commission and to terminate the above-captioned proceeding.

Specifically, Trinsic moves to withdraw its July 22, 2004 notice to this

Commission regarding Trinsic's adoption of the existing BellSouth and Network

Telephone interconnection agreement pursuant to section 252(i) of the Communications

Act, 47 U.S.C. § 252(i). In addition, BellSouth moves to withdraw its request for hearing

pursuant to Section 120.57, F.S. and its protest of proposed agency action in Order PSC
05-0158-PAA-TP. As a result of these withdrawals, no additional issues are pending

before the Commission in this proceeding, and accordingly, this proceeding should be

terminated.
