MEMORANDUM OF POINTS AND AUTHORITIES

Atlas Equity, Inc., the above-referenced reorganized debtor ("Atlas") and interest holder Vincent E. Galewick

("Galewick") hereby move this Court for entry of a final decree pursuant to 11 U.S.C. § 350(a) and Federal Rule of Bankruptcy

Procedure 3022 closing this chapter 11 case. This motion is made on the grounds that the estate has been fully administered.

In support of its motion, Atlas and Galewick represent as follows:

10 I. PROCEDURAL BACKGROUND

A. The Original Chapter 11 Case and Conversion

Atlas filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code on December 22, 1998. A chapter 11 trustee was quickly appointed and later the case was converted to chapter 7. The chapter 7 trustee reduced Atlas's tangible assets and held approximately \$42,000 in cash on hand. The trustee informed Galewick that most of the cash on hand would be spent in administering the estate through the chapter 7 case.

B. Re-Conversion to Chapter 11 and Plan Confirmation

At that point, Galewick moved to re-convert this case to chapter 11 in order to propose a chapter 11 plan. Instead of using all of the cash on hand to pay more fees to the trustee and his lawyers, Galewick and Atlas proposed a joint plan that provides for distribution of all remaining cash on hand to creditors of Atlas, without the burden of further administrative expenses (administrative expenses incurred after re-conversion are to be paid by Galewick). In December 2003, the Court entered its order re-converting this case to chapter 11, and ordered the

1 cash on hand to be held (the "Reserved Funds") pending further 2 order of the Court.

On November 18, 2004, this Court entered its order 4 confirming the Second Amended Joint Chapter 11 Plan (the "Plan") 5 proposed by Atlas and Galewick. Among other things, the Plan 6 provides for distribution of the Reserved Funds to creditors 7 holding allowed claims. In particular, the Plan provides for the following treatment of claims and interests:

- · Administrative Claims. The Plan provides that all allowed administrative claims will be paid in full on the later of (i) the Effective Date of the Plan; or (ii) upon entry of an order allowing such claim. After confirmation of the Plan, the Trustee filed his chapter 7 final report and he and his counsel sought and obtained Court approval of chapter 7 fees and expenses in the total aggregate amount of \$18,889.90 ("Pre-Conversion Administrative Expenses");
- · Class 1 Priority Unsecured Claims. The Plan provides that all allowed priority unsecured claims will be paid in full in cash on the first Business Day that is 30 days after entry of an order of this Court allowing or disallowing the last of any request for payment of Pre-Conversion Administrative Expenses;
- · Class 2 General Unsecured Claims. The Plan provides that all allowed general unsecured claims will be paid in cash a pro rata share of the remaining Reserved Funds (after payment of allowed Pre-Conversion Administrative Expenses) on the first business day that

is 30 days after entry of an order of this Court allowing or disallowing the last of any request for payment of Pre-Conversion Administrative Expenses;

 Class 3 - Interest Holder Vincent Galewick. The Plan provides that Galewick will retain his 100% equity interest in Atlas.

After, confirmation of the Plan, Atlas and Galewick successfully objected to several dozen claims that were 10 erroneously filed against Atlas (such claims were claims against 11 affiliates of Atlas), were time-barred, or otherwise not 12 allowable as claims against Atlas.

Atlas has completed making all Plan payments to 14 administrative, Class 1, and Class 2 creditors. As a result, 15 Atlas has satisfied all of its obligations to creditors under the 16 Plan.

There are no pending adversary proceedings or contested 18 matters in this case. Atlas will pay any outstanding fees due to 19 the Office of the United States Trustee concurrently with the 20 filing of this Motion.

21 II. ISSUANCE OF FINAL DECREE

The Estate Has Been Fully Administered

Bankruptcy Code section 350 provides that the court shall 24 close a bankruptcy case after the estate is fully administered. 25 More specifically, Rule 3022 of the Federal Rules of Bankruptcy 26 Procedure provides:

> After an estate is fully administered in a chapter 11 reorganization case, the court, on its own motion or on

motion of a party in interest, shall enter a final decree closing the case.

The 1991 Advisory Committee Note to Rule 3022 explains the concept of full administration of a chapter 11 case:

Factors that the court should consider in determining whether the estate has been fully administered include (1) whether the order confirming the plan has become final, (2) whether deposits required by the plan have been distributed, (3) whether the property proposed by the plan to be transferred has been transferred, (4) whether the debtor or the successor to the debtor has assumed the business or management of the property dealt with by the plan, (5) whether payments under the plan have commenced, and (6) whether all motions, contested matters, and adversary proceedings have been finally resolved.

Under the Plan, Atlas is the disbursing agent charged with making the distributions necessary for consummation of the Plan. In accordance with the Plan, Atlas has made all distributions called for under the Plan. Concurrently with the filing of this motion has paid all outstanding United States Trustee fees. All other motions, contested matters and adversary proceedings have been finally resolved. Accordingly, based on the factors set forth above, the Plan is fully administered and it is necessary and appropriate that the Court enter a final decree closing the case.

- 3 1. I am the Chief Financial Officer of Atlas Equity, Inc. ("Atlas"), the reorganized in the above-captioned chapter 11 case. I am a certified public accountant. I make this 6 declaration in support of Atlas' Omnibus Objections to Claims (the "Claims Objections"). Since the re-conversion of Atlas' 8 bankruptcy case to chapter 11, I have been the person primarily 9 responsible for management of Atlas. I have personal knowledge 10 of the facts set forth herein, except as to those matters stated 11 on information and belief and, as to those matters, I believe them to be true. If called as a witness, I could and would 13 testify competently to the facts stated herein.
- 2. I am one of the custodians of Atlas' documents, books and records regarding its business. Atlas' documents, books, and 16 records regarding its business were compiled in the ordinary course of the company's business at or near the time or occurrence of the events of which they are record, and are or 19 were made by persons who have a business duty to Atlas to make such records.
- Since confirmation of the estate's Second Amended Joint 22 Chapter 11 Plan, as Modified on September 1, 2004 (the "Plan"), I 23 have individually and through Atlas' agents, accountants, and 24 attorneys, reviewed the claims register compiled by the Clerk of 25 the Court, the proofs of claim, Atlas' original Schedules and amended Schedules, and the orders entered by this Court allowing 27 and/or disallowing various claims. Based upon such review and

1 evaluation, I am familiar with the allowed claims that are 2 entitled to receive distributions pursuant to the Plan. 3 Atlas has completed making all Plan payments to administrative, 4 Class 1, and Class 2 creditors.
