STAFF'S PRELIMINARY LIST OF ISSUES AND POSITIONS

Pursuant to Order No. PSC-05-0277-PCO-EG, issued March 15, 2005, establishing the prehearing procedures in this Docket, the Staff of the Florida Public Service Commission hereby files its Preliminary List of Issues and Positions.

GENERIC CONSERVATION COST RECOVERY ISSUES

**ISSUE 1:** What are the appropriate final conservation cost recovery true-up amounts for the period January 2004 through December 2004?

**POSITION:** No position at this time for all companies pending further review.

**ISSUE 2:** What are the appropriate conservation cost recovery factors for the period January 2006 through December 2006?

**POSITION:** No position at this time for all companies pending further review.

**ISSUE 3:** What should be the effective date of the new conservation cost recovery factors for billing purposes?

**POSITION:** The factors should be effective beginning with the specified conservation cost recovery cycle and thereafter for the period January, 2006, through December, 2006. Billing cycles may start before January 1, 2006, and the last cycle may be read after December 31, 2006, so that each customer is billed for twelve months regardless of when the adjustment factor became effective.

COMPANY SPECIFIC ISSUES

**ISSUE 4:** What is the Contracted Credit Value for the GSLM-2 and GSLM-3 rate riders for Tampa Electric Company for the period January 2006 through December 2006?

**POSITION:** No position at this time pending further review.
