**SUPPLEMENT TO PETITION
OF TAMPA ELECTRIC COMPANY**

Tampa Electric Company ("Tampa Electric" or "the company") hereby supplements the Petition filed September 9, 2005 in the above proceeding as follows:

1. Tampa Electric is filing this date a Motion for Leave to File Supplemental Testimonies and Exhibits of witness Carlos Aldazabal updating the company's actual/estimated true-up for 2005 to encompass actual cost data as opposed to estimated cost data for the months of July and August of 2005. Inclusion of this actual data carries over and affects the projection testimony and exhibit of Mr. Aldazabal pertaining to calendar year 2006.

2. The updated cost information set forth in Mr. Aldazabal's revised testimonies and exhibits have the impact of changing the company's projected fuel and purchased power cost recovery factor on a per kWh basis before application of the factors which adjust for variations in line losses from 5.254 cents per kWh to 5.413 cents per kWh.

3. No other aspects of the petition filed September 9, 2005 in this proceeding require any change as a result of the updated testimonies and exhibits of Mr. Aldazabal.

WHEREFORE, Tampa Electric Company requests that its fuel and purchased cost recovery factor for the period January 1, 2006 through December 31, 2006 be approved at a level


