JOINT MOTION FOR EXTENSION OF TIME

NOW Comes, BellSouth Telecommunications, Inc. ("BellSouth") and NewSouth Communications Corp., NuVox Communications Corp., and Xspedius Communications, LLC (collectively referred to as "Joint Petitioners") who jointly ask the Florida Public Service Commission ("Commission") for a thirty (30) day extension of time or until December 9, 2005 in which to execute and file an executed interconnection agreement in the above-captioned proceeding. Pursuant to Order No. PSC-05-0975-FOF-TP, the parties are required to file a final executed interconnection agreement with the Commission on November 10, 2005. The parties need additional time to negotiate the final agreement. As all parties are seeking this extension, no party will be prejudiced by the granting of an additional thirty (30) days in which to file a final interconnection agreement with the Commission.
