JOINT MOTION FOR EXTENSION OF TIME

NOW Comes, BellSouth Telecommunications, Inc. ("BellSouth") and NewSouth Communications Corp., NuVox Communications Corp., and Xspedius Communications, LLC (collectively referred to as "Joint Petitioners") who jointly ask the Florida Public Service Commission ("Commission") for a thirty (30) day extension of time or until December 9, 2005 in which to execute and file an executed interconnection agreement in the above-captioned proceeding.
