On October 31, 2005, a tariff revision was filed with the Division of Competitive Markets and Enforcement on behalf of Verizon Select Services Inc. (VSSI). The filing included confidential work papers, which were filed with the Division of the Commission Clerk, that illustrate that VSSI is required to flow through \$336,084.29 in annual revenues.

Verizon considers this information to be confidential as it contains proprietary information that could be used by competitors to gain an unfair competitive advantage. Therefore, this filing is made under a Claim of Confidentiality pursuant to F.S. 364.183(1) and Rule 25-22.006(5).
