The water and sewage systems were permitted by the state and county and complied with all the standards set forth by these government agencies.

I also object to MSM Utilities, LLC. (A private development company) attempting to force me, thru state intervention, to underwrite their cost of further developing the property, which at this time is under the jurisdiction of the two aforementioned water certificates.

The property owners in this area have suffered Financially because of the hurricane last year. This annexation would add significant cost to these properties and more tax liability.

Most of these property owners are retired or low-income families who cannot afford a service that only benefits a private corporation.
