Charlotte County made us have our septic system cleaned and inspected, before we could obtain an occupancy permit for our new home, at the above address. The Water and sewage systems were permitted by the state and county and complied with all the standards set forth by these government agencies. BY THESE STANDARDS THESE SYSTEMS ARE COMPLETELY ADEQUATE.

The majority of these property owners are retired living on fixed incomes, who cannot afford a service that only benefits a private company. This annexation would increase significant cost to our property and tax liability.

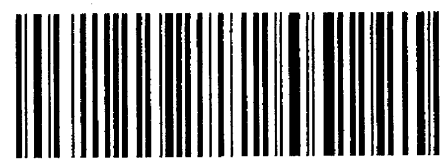
