

Q. Please state your name and business address.

A. My name is Patrick C. Flynn and my business address is 200 Weathersfield Avenue, Altamonte Springs, Florida.

Q. By whom are you employed and in what capacity?

A. I am employed by Utilities, Inc., the company which owns 100% of the stock of Sanlando Utilities Corporation (*Sanlando*). Presently, I serve as Regional Director of Operations and am responsible for the administration and operation of all water and sewer systems in Florida owned by subsidiaries of Utilities, Inc.

Q. Please summarize your background and experience in the industry of providing water and sewer service to the public.

A. I am a graduate of the University of Virginia with a B. A. degree in Environmental Science. I first became involved in the industry with my employment with the Washington Suburban Sanitary Commission in 1979. In 1982, I was hired by an investor-owned water and wastewater utility on Hilton Head Island, South Carolina, serving as the Vice President and General Manager from 1984 to 1995.

In 1995, I was hired by Utilities, Inc. to serve as Project Manager in the Louisiana regional office. In 1999, I became a Regional Operations Manager in Florida where I was initially responsible for

1 the day to day utility operations of some of the Utilities, Inc.
2 affiliates in central Florida. In 2000, I began supervising the
3 operations and capital projects of all Utilities, Inc. affiliates located
4 in north, west, and south Florida. Effective June 2003 I became
5 the Regional Director in Florida with responsibility over all of the
6 affiliates located in Florida.

7 I previously held a Class D wastewater operator license in Maryland
8 and Class A certificates in both water and wastewater in South
9 Carolina and Louisiana. In addition, I hold a Class B water
10 certificate in Florida. I have attended numerous seminars,
11 workshops, conferences, classes and schools covering a wide
12 spectrum of water and wastewater related topics.

13 Q. What is the purpose of your testimony in this proceeding?

14 A. To sponsor the Application for Amendment to Certificates of
15 Authorization, as amended in its entirety. True and correct copies
16 of the Amended and Restated Application for Amendment to
17 Certificates of Authorization (*PCF-1*) and the Second Amendment
18 to Application for Amendment to Certificates of Authorization,
19 including all Exhibits thereto (*PCF-2*), are attached to my
20 testimony.

21 Q. Does this conclude your direct testimony?

22 A. Yes it does.

AMENDED AND RESTATED APPLICATION FOR AMENDMENT TO
CERTIFICATES OF AUTHORIZATION

SANLANDO UTILITIES CORPORATION, ("Applicant"), by and through its undersigned attorneys, and pursuant to Section 367.045(2), Florida Statutes, and Rule 25-30.036, Florida Administrative Code, files this Amended and Restated Application for Amendment of Water Certificate No. 247-W and Wastewater Certificate No. 189-S to correct inconsistencies and consolidate the legal descriptions of its certificated water and wastewater service areas as described in this Amended and Restated Application ("Consolidated Service Areas"), in Seminole County, and in support thereof states:

1. The exact name of the Applicant and the address of its principal business offices are:

3. The Applicant has been in operation since the 1970's. Since that time, its certificated service areas have been amended a number of times.

4. In Docket No. 030485-SU, the Commission approved the extension of the Applicant's wastewater service area to include a new single-family development in Seminole County, Florida. In Docket No. 030667-WS, the Commission amended the Applicant's water and wastewater certificates to add and delete areas of its certificated water and wastewater service areas that overlapped with the certificated water and wastewater service areas of Florida Water Services Corporation.

5. In the process of reviewing and examining its certificated service areas, the Applicant discovered that it has been providing service to areas that were inadvertently not included in the existing legal description of its water and wastewater service areas. In addition, the Applicant wishes to add certain areas to its water and wastewater service areas. These areas are more fully described in Exhibit "A".

6. The purposes of this Application are consolidate and correct certain inconsistencies in the legal descriptions of the Applicant's certificated water and wastewater service areas, to include those areas to which the Applicant has been providing service which

are not within the current legal description, to add certain areas which are located within the Applicant's service area and to provide the Commission and the Applicant's customers with a single, consolidated, uniform legal description of the boundaries of each of its certificated water service and wastewater service areas.

7. As required by Rule 25-30.036, the Applicant provides the following information:

(a) The Applicant's complete name and address are as set out above.

(b) The Applicant is an established utility and has both the financial and technical ability to render reasonably sufficient, adequate and efficient service. The Applicant's most recent financial statements from the Applicant's 2003 Annual Report are attached as Exhibit "B". With respect to the Applicant's technical ability, attached as Exhibit "C" is a schedule listing the operators and their license numbers. There are no outstanding Consent Orders or Notices of Violation from DEP.

(c) To the best of the Applicant's knowledge, the provision by the Applicant of water and wastewater service to the Consolidated Service Areas is consistent with the water and wastewater sections of the Seminole County Comprehensive Plan at the time this Application is filed, as approved by the Department of Community Affairs.

(d) Documentary evidence of the Applicant's ownership of the land on which its plants are constructed is attached as Exhibit "D".

(e) A description of the territory proposed to be served, using township, range and section references, is attached as Exhibit "E".

(f) One copy of each of the detailed water and wastewater system maps

showing the lines, treatment facilities and the territory proposed to be served is attached hereto as Exhibit "F".

(g) The Applicant is not planning to build a new wastewater treatment plant. The Applicant has completed an upgrade its Wekiva wastewater treatment plant for the purpose of providing a public access reuse system.

(h) The Applicant has constructed a public access reuse system at its Wekiva wastewater treatment plant.

(i) Maps of the Consolidated Service Areas showing township, range and section, are attached as Exhibits "G" (Water) and "H" (Wastewater). Full-sized maps will be provided to Commission Staff under separate cover.

(j) The capacity of the existing lines and treatment facilities and the design capacity of the reuse system are as follows:

The number of wastewater ERCs for the combined systems as of the end of December 2003 is 9,268. The average daily flow for the Wekiva plant over the previous 12 months is 2.2 MGD. As of the date of this Application, the Applicant has sufficient capacity to serve

additional demand of up to 2,500 ERC's, assuming current usage patterns. The Applicant does not propose to extend its existing facilities at this time. The existing lines and treatment facilities currently serving the Consolidated Service Areas have sufficient capacity to serve the Consolidated Service Areas.

(k) The numbers and dates of permits issued by the Department of Environmental Protection are:

* These permits are in the process of renewal.

(l) No new construction is anticipated; therefore the Applicant will not require financing. There will not be any impact on the Applicant's capital structure.

(m) The Applicant serves primarily residential customers. This Application is not intended to, nor will it, affect the type or quality of service already provided by the Applicant. The amendment of the Applicant's water and wastewater certificates for the purposes described in this Application will not interrupt, curtail or otherwise affect the provision of water and wastewater service to the Applicant's existing customers.

(n) The amendment of the Applicant's certificated water and wastewater service areas for the purposes described in this Application will not have any impact on the Applicant's rates or service availability charges.

(o) Attached as Exhibit "I" to this Application are the original and two copies of

the revised water and wastewater tariff sheets reflecting the Consolidated Services Areas. Copies of the revised tariff sheets are attached to each copy of the Application.

(p) Copies of the original water and wastewater certificates are attached as Exhibit "J". The Applicant has not been able to locate the original certificate and requests replacement certificates which incorporate the amendments requested in this Application.

(q) Rates for the Applicant were last changed by the Commission in Order No. PSC-00-2097-AS-WS.

(r) In response to Section 367.045(2)(c), Florida Statutes, attached hereto as Exhibit "K" is an Affidavit that the Applicant has on file with the Commission a tariff and current annual report.

8. The approval of this Application is in the public interest because there is a need to correct the inconsistencies in the legal descriptions of the Applicant's certificated water and wastewater service areas, to add areas which have requested service and to provide Commission Staff and the Applicant's customers with a single, consolidated, uniform description of the boundaries of the Applicant's certificated water and wastewater service areas. The amendment of the Applicant's water and wastewater certificates for these purposes will also provide certainty and greater ease of reference to both Commission Staff and the public . It is in the public interest for the Applicant's water and wastewater certificates to be amended for these purposes.

9. The Applicant has previously filed an Affidavit that notice of the Application was given in accordance with Section 367.045(1)(a), Florida Statutes, and Rule 25-30.030, Florida Administrative Code, by regular mail to the following:

- (1) the governing body of the municipality, county or counties in which the system or territory proposed to be served is located;
- (2) the privately owned water utility that holds a certificate granted by the Public Service Commission and that is located within the county in which the utility or the territory proposed to be served is located;
- (3) if any portion of the proposed territory is within one mile of a county boundary, the utility shall notice the privately owned utilities located in the bordering counties and holding a certificate granted by the Commission;
- (4) the regional planning council;
- (5) the Office of Public Counsel;
- (6) the Public Service Commission's Director of Records and Reporting;
- (7) the appropriate regional office of the Department of Environmental Protection; and
- (8) the appropriate water management district;

Copies of the Notice and a list of entities noticed shall accompany the affidavit.

10. The Applicant has previously filed an Affidavit that notice of the Application was given in accordance with Rule 25-30.030, Florida Administrative Code, by regular mail or personal delivery to each property owner in the Consolidated Service Areas.



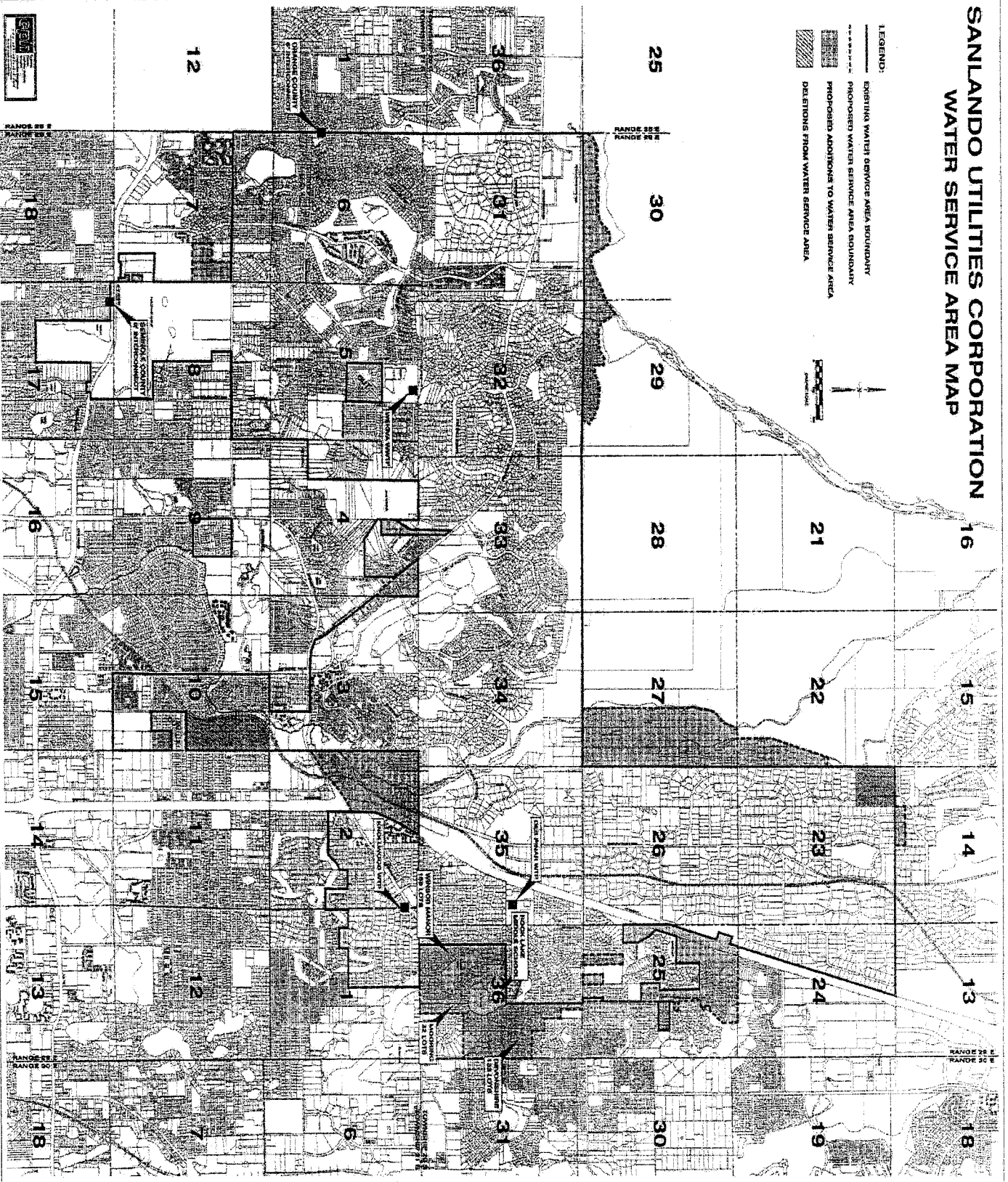

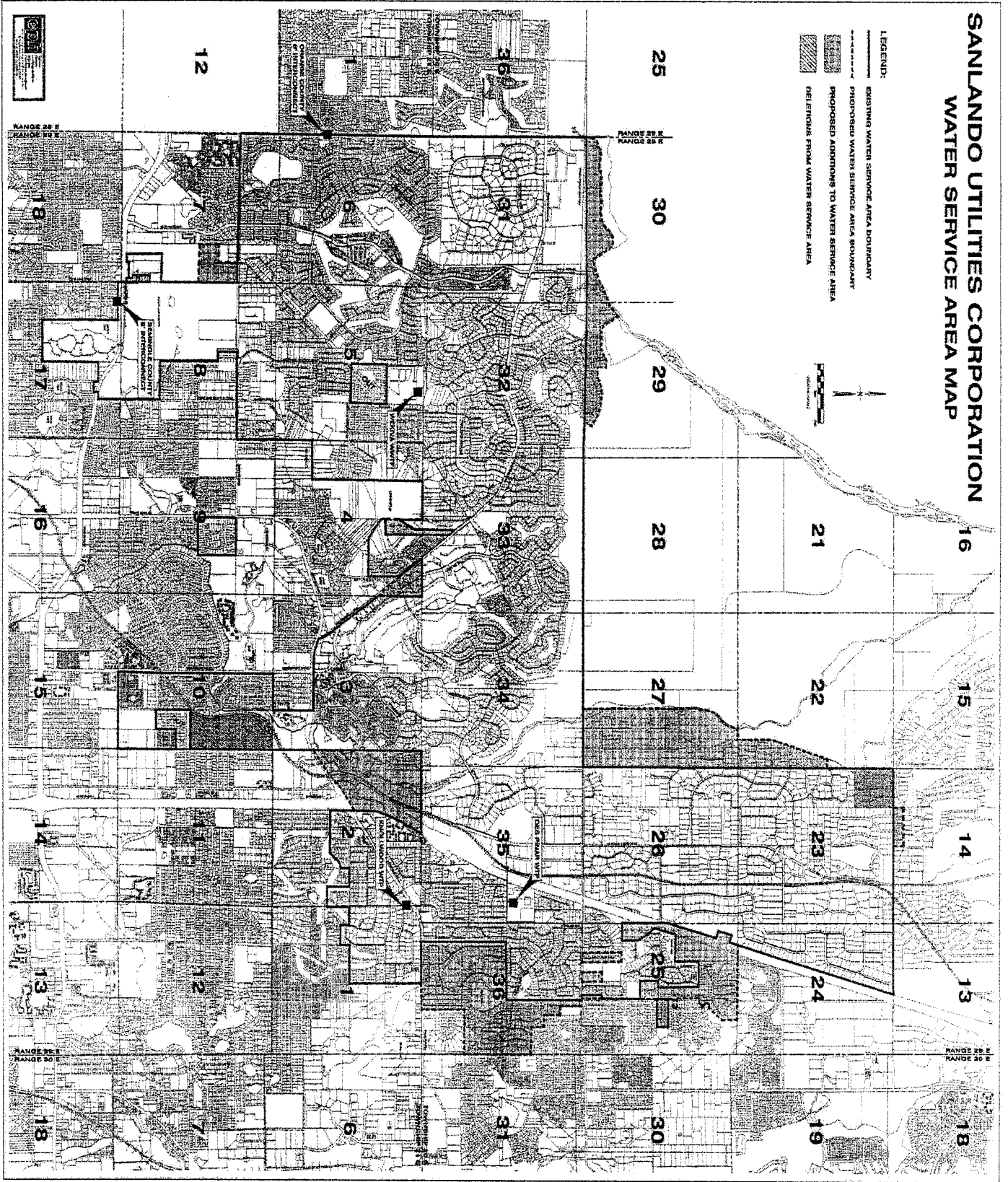

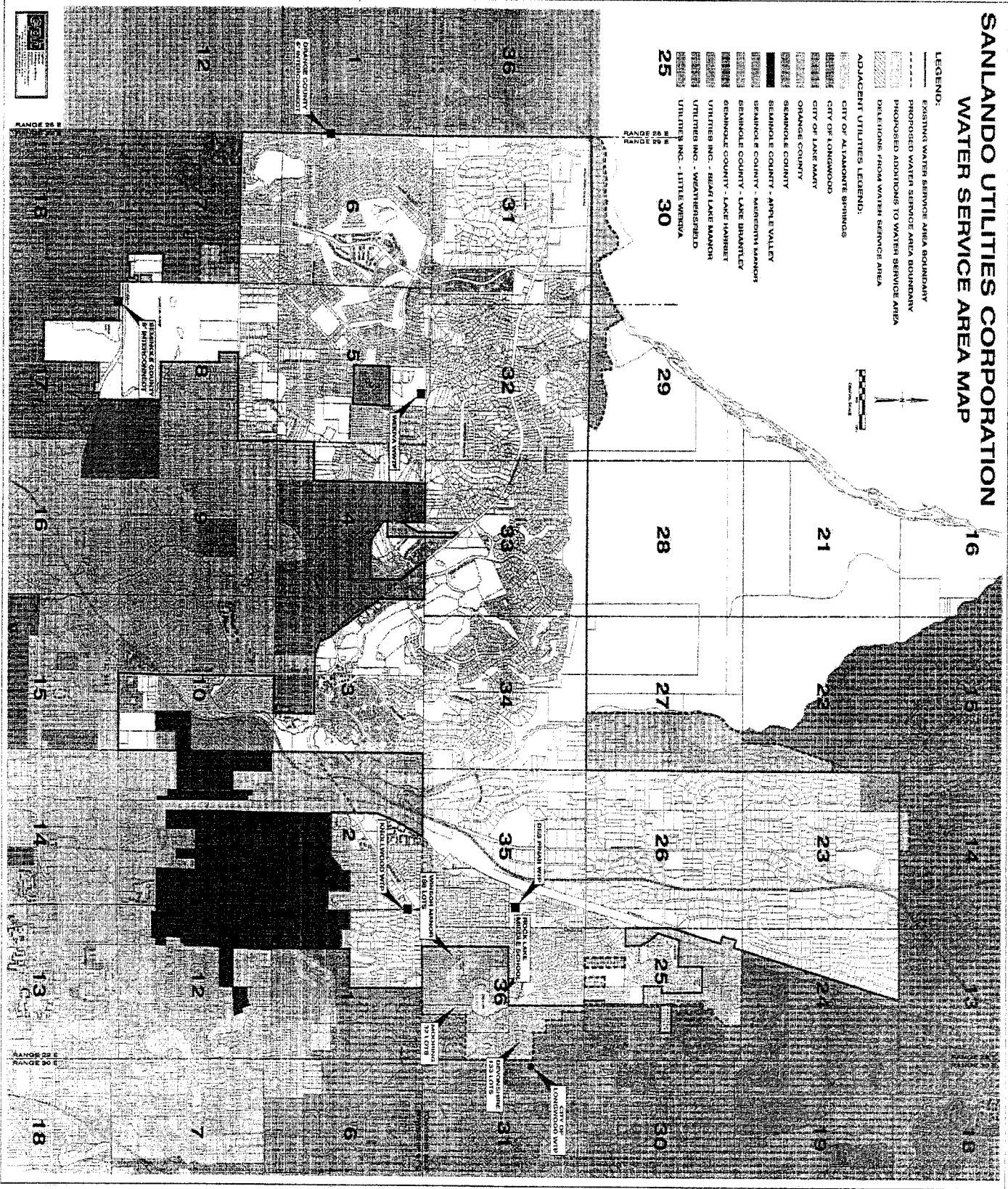
SANLANDO UTILITIES CORPORATION WASTEWATER SERVICE AREA MAP

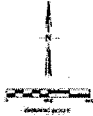





SANLANDO UTILITIES CORPORATION WASTEWATER SERVICE AREA MAP

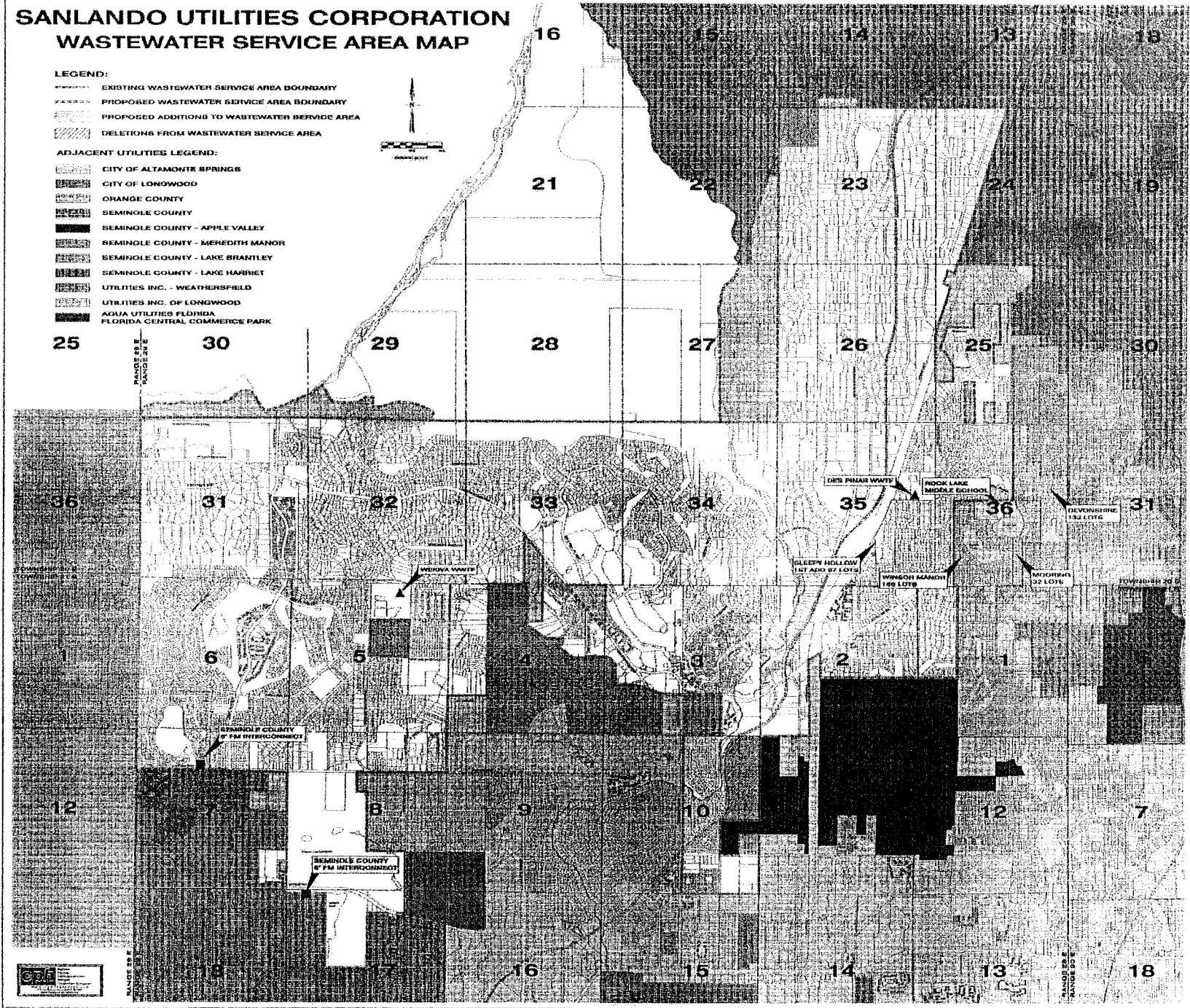
