Notification of Consummation of Transfer of Control, Update to Utility Contact
Information, and Revised Tariff

Ladies and Gentlemen:

Manhattan Telecommunications Corporation, d/b/a Metropolitan Telecommunications Corporation ("MetTel") and Business Productivity Solutions, Inc. ("BPS" and, together with MetTel, "the Parties"), through their undersigned counsel, hereby notify the Florida Public Service Commission ("Commission") that the Parties obtained necessary regulatory approvals and therefore consummated their proposed transfer of control. BPS is currently a direct, wholly-owned subsidiary of Manhattan Telecommunications Corporation and indirect, wholly-owned subsidiary of Manhattan Telecommunications Corporation's holding company parent, Metropolitan Telecommunications Holding Company. See Post-Transaction Organization Chart at Attachment 1.

Notice of Consummation of Transfer of Control

On August 16, 2005, the Parties notified the Commission of their intent to consummate a transfer of control of BPS to MetTel. The Parties notified the Commission they would close their transaction upon receipt of regulatory approvals. The Parties received regulatory approvals and therefore consummated their transaction.

Utility Contact Update

To ensure the Commission has current, post-transfer contact information for BPS, MetTel provides the attached Utility Contact update information. See Attachment 2. MetTel and its subsidiary BPS respectfully request the Commission use the attached Utility Contact update form to ensure its records and databases are promptly updated to reflect BPS' new corporate address and regulatory/utility contacts. Taking the requested actions promptly will help avoid misdirected communications and thereby minimize the potential for delayed responses to Commission correspondence and consumer complaints, missed regulatory filings and other avoidable administrative problems.

Notice of Tariff Filing

Concurrently with this filing, under separate transmittal letter, MetTel submits a revised tariff on behalf of its wholly-owned subsidiary, BPS. The revised tariff also contains updated contact information reflecting the transfer of BPS to MetTel.

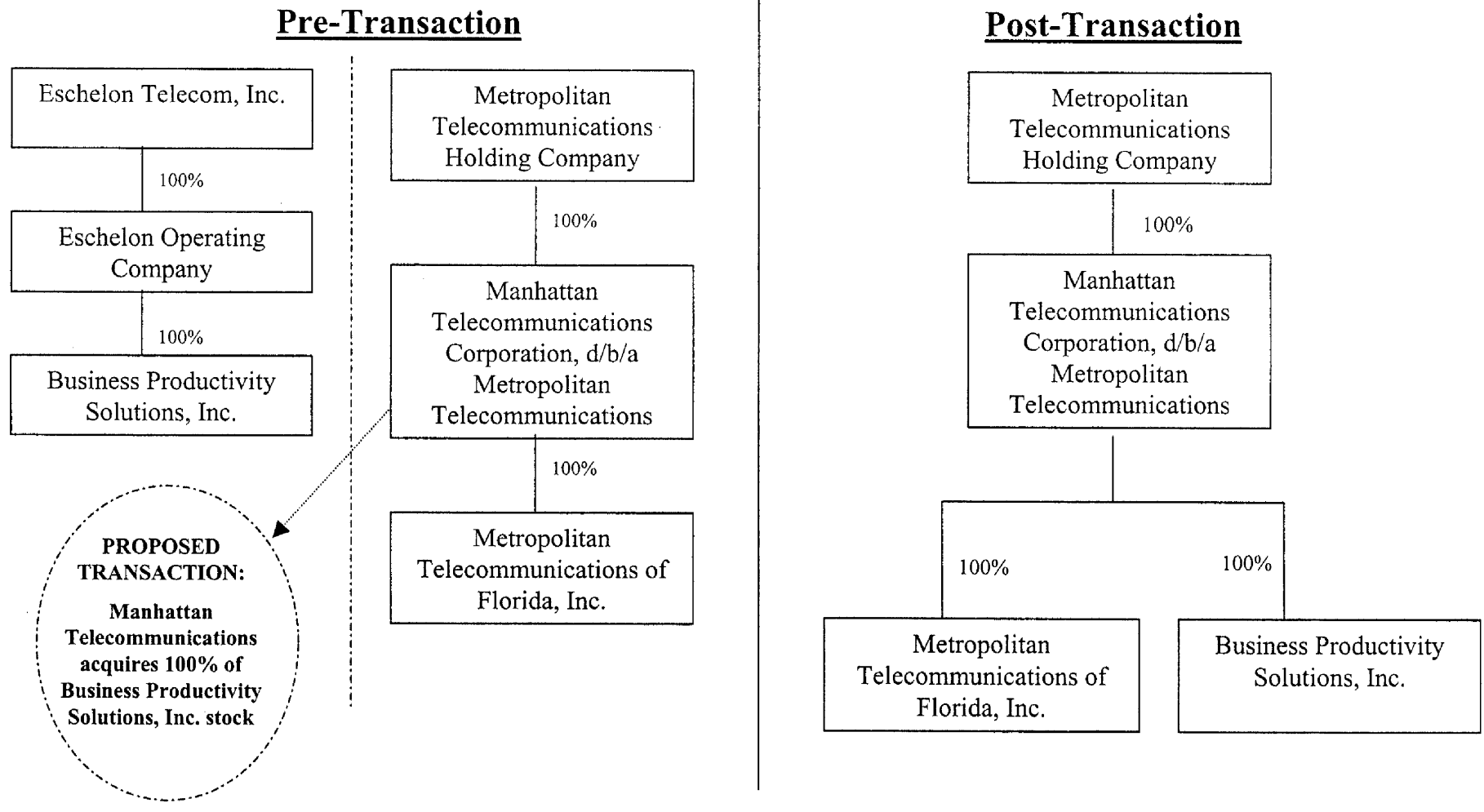
