





I, Charles F. Palmer, being first duly sworn, do hereby depose and state as follows:



information, and belief.

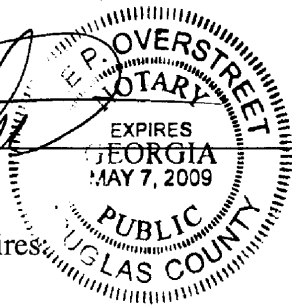


