Pursuant to our prior commitment with the Florida Public Service Commission, I am providing to you and all other parties to this proceeding our status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the months of September, October, November and December, 2005.

During these months, all negotiations were completed on the transaction documents for the sale of the Zellwood system and wholesale supply transaction with the City of Apopka. Closing was set for November 30, 2005 and was due to proceed. Prior to closing, Zellwood was informed that the closing would be temporarily delayed while Orange County and the City of Apopka worked out an unrelated land use matter. To the best of our knowledge at this point, the County should be ready to close on or before March of 2006. As of now, Zellwood can only wait for the County and the City of Apopka to be ready to close.
