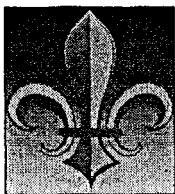

United Telecommunication Services, Inc. wishes to keep the Certificate active and in compliance with Commission rules. The Company apologizes for the oversight in filing this document. They feel it may have been due to a misunderstanding by their accounting firm. The Company has taken steps to prevent further late payments of the regulatory assessment fees including transferring these responsibilities to our regulatory consulting firm.

The Company agrees to waive any objection to the administrative cancellation of its certificate should United Telecommunication Services, Inc. fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision of the settlement, Commission staff will bring the matter to the Commission for consideration.

United Telecommunication Services, Inc. respectfully proposes to pay \$100 (not enclosed) as a monetary settlement for the violation. This balance will be paid as per Commission instructions after the Commission Order is issued.
