On November 17, 2005, Sprint-Florida, Incorporated (Sprint) requested additional numbering resources from the Number Pooling Administrator (NeuStar), for the Ft. Myers exchange, South Ft. Myers (FTMYFLXCD52) switch. Sprint requested these numbers to meet a customer's request, specifically one (1) 1,000 block of consecutive numbers in the 8000 or 8999 block. On January 9, 2006, Sprint's request for additional numbering resources was denied because it did not meet the months-to-exhaust utilization criteria required for new blocks of numbers.

On January 9, 2006, Sprint filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the Sprint petition and has determined the following:

- 1) The carrier has demonstrated that it has customers in need of numbering resources:
- 2) The carrier has shown that it is unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) The customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.
