On December 20, 2005, Sprint-Florida, Incorporated (Sprint) requested additional numbering resources from the Number Pooling Administrator (NeuStar), for the Belleview exchange, Belleview (BLVWFLXADS0) switch. Sprint requested one (1) 1,000 block of numbers to meet a customer's request for 100 consecutive numbers. Also on December 20, 2005, Sprint's request for additional numbering resources was denied by NeuStar because it did not meet the months-to-exhaust utilization criteria required for a new block of numbers.

On January 11, 2006, Sprint filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the Sprint petition and has determined the following:

- 1) The carrier has demonstrated that it has customers in need of numbering resources;
- 2) The carrier has shown that it is unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) The customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of PSC-02-0352-PAA-TL have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (January 31, 2006), as outlined in the expedited code denial process order. NeuStar should be directed to provide Sprint the needed numbering resources to meet its customer's needs in the Belleview exchange, Belleview (BLVWFLXADS0) switch. Also, please allow staff assigned to the docket to review the Order before it is issued. If you have any questions, please call Catherine Beard at (850) 413-7080.
