
Please amend the telephone number for ANEW's representative. It should be 305.261.7778 (ext 139).

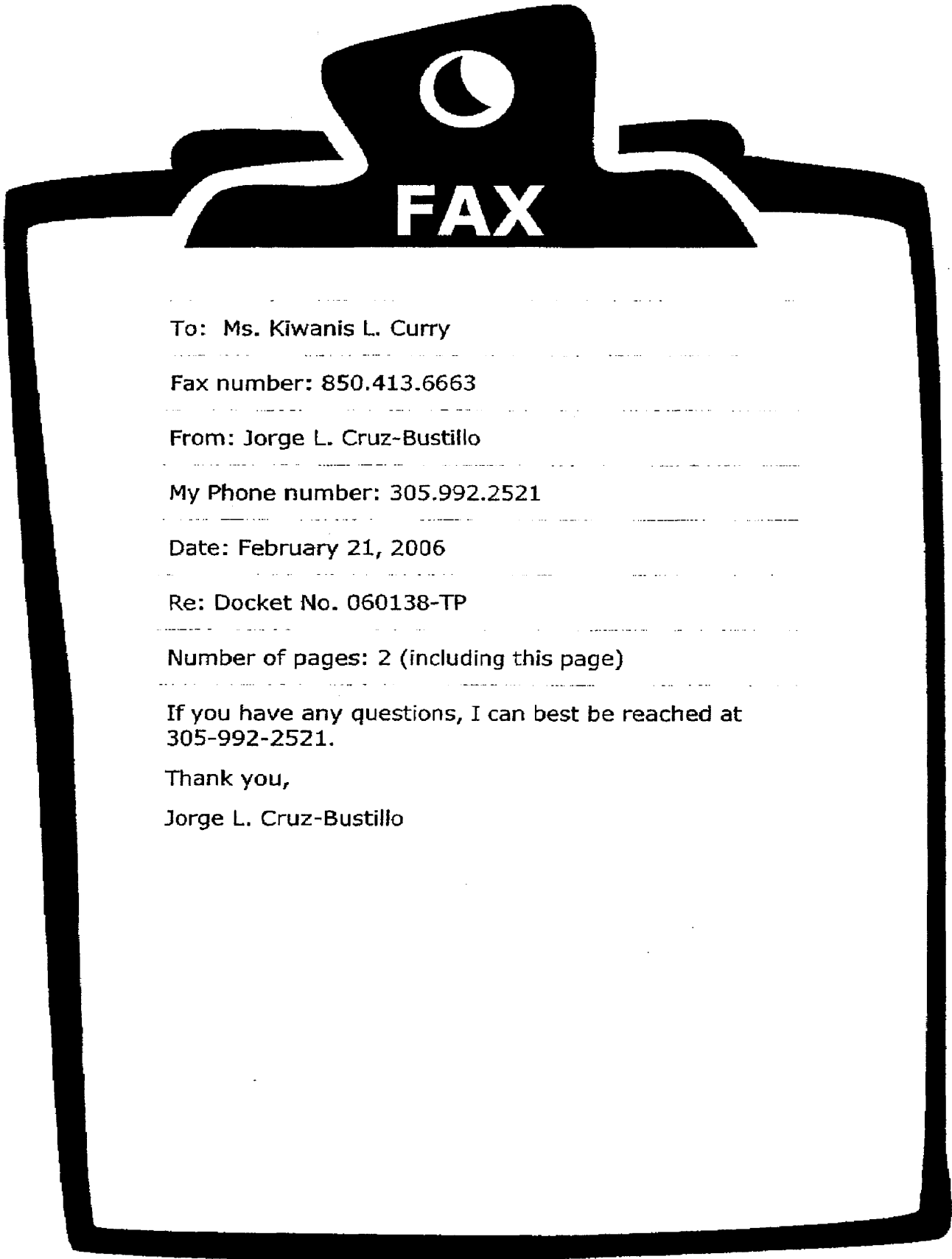
