The attached letter, dated August 9, 2005, was sent to your company regarding BellSouth's, Verizon's, and Sprint's intrastate switched access charges being reduced to interstate parity as a result of this Commission's Order No. PSC-03-1469-FOF-TL (Order) issued on December 24, 2003. The attached letter delineated the Interexchange Carriers (IXCs) filing requirements as a result of the Order being issued. The filing requirements varied based on the access charges paid within the most current twelve month period by your company. Additionally, any IXC whose intrastate switched access expense reduction is \$100 or less per month would not be obligated to flow through its reduction, but must attest to such through a letter filed with this Commission. As of January 10, 2006, we are not in receipt of a response from your company. Please forward the required response by March 10, 2006.
