By Order No. PSC-05-1123-PAA-TL, issued November 7, 2005, the Florida Public Service Commission (FPSC) approved a BellSouth petition to realign the boundaries of the St. Johns rate center and consolidate the Julington and St. Augustine rate centers with the St. Johns rate center. On February 24, 2006, BellSouth issued Carrier Notification letter SN91086037 which advised that an industry meeting would be held March 14, 2006 to discuss the realignments and rate center consolidations.
