RE: Docket No. 060326-TL – Recommendation to Office of the General Counsel – Petition for expedited review of growth code denials by Number Pooling Administrator for West Palm Beach exchange (Haverhill), by BellSouth Telecommunications, Inc. *PK*

On March 27, 2006, BellSouth Telecommunication, Inc. (BellSouth) requested additional numbering resources from the Number Pooling Administrator (NeuStar), for the West Palm Beach exchange, Haverhill (WPBHFLHHDS0) switch. BellSouth requested these numbers to meet a customer's request, specifically one (1) 1,000 block of numbers in the format NPA NX8. On March 27, 2006, BellSouth's request for additional numbering resources was denied because it did not meet the months-to-exhaust utilization criteria required for new blocks of numbers.

On April 6, 2006, BellSouth filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the BellSouth petition and has determined the following:

RCA \_\_\_\_\_ Since the three criteria of PSC-02-0352-PAA-TL have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (April 25, 2006), as outlined in the expedited code denial process order. NeuStar should be directed to provide BellSouth the needed numbering resources to meet its customer's needs in the West Palm Beach exchange, Haverhill (WPBHFLHHDS0) switch.
