DR-4.4a-b contains detailed data on Gulf Power's financial and operational target goals and results for the period 1999-2005. These target and results goals are the basis for Gulf Power's Performance Pay Program held confidential in DR-2.3e and are considered by the company as proprietary business information. Staff believes Gulf's request that this information not be disclosed to the general public is reasonable. Staff believes pages 2-3 of DR-4.4a-b should remain under confidential protection, pursuant to F.S. section 366.093(3)(e).
Work papers Page 8, lines 3 and 4 of auditors handwritten notes dated 10/19/05 and titled "Audits- Reliability Review"	Pursuant to F.S. section 366.093(3)(d); references a specific monetary amount paid to an outside contractor; as contractual data the disclosure would impair Gulf's efforts to contract goods and services on favorable terms.	Lines 3-4 on page 8 of the auditor's notes specifies Gulf Power's contractor for tree trimming services, the dates of the contract, and the total expenditure level for the contract. Gulf Power has not claimed confidentiality for the total annual tree trimming expenditure data provided in staff's report, but seeks to protect the individual contracted rates for specific contractors and contracts. Staff believes this request is reasonable and should be allowed pursuant to F.S. section 366.093(3)(d).
Work papers Page 4, lines 8-27 and page 5, lines 1-8 of auditors handwritten notes titled "Responses to Audits & Recs."	Pursuant to F.S. section 366.093(3)(b); summarizes the results of an internal compliance audit performed by Gulf Power of its Pensacola District.	This request seeks to redact auditor summary notes for a compliance audit performed by Southern Company auditors. This data is considered as proprietary business information regarding internal auditing controls and reports of internal auditors. Pursuant to F.S. section 366.093(3)(b), staff believes this request is reasonable and should be allowed.
