## JOINT STATUS REPORT

On April 2, 1991, the Florida Public Service Commission ("Commission") approved the Territorial Agreement between Florida Power Corporation, d/b/a, Progress Energy Florida, Inc. ("PEF"), and Clay Electric Cooperative, Inc. ("Clay Electric") regarding their territorial boundaries in Alachua County, Florida.

Section 5.1 of the Agreement provides as follows:

"Section 5.1: This Agreement shall continue and remain in effect for a period of fifteen years from the date of the Commission's initial Order approving this Agreement, and shall be automatically renewed for additional fifteen (15) year periods unless either Party gives written notice to the other of its intent not to renew at least six months (6) months prior to the expiration of any fifteen (15) year period; provided, however, that each such renewal of this Agreement shall require prerequisite approval of the Commission with the same effect as the original Commission approval of this Agreement as required and provided for in Article 4 hereof."

This year, neither party to the Agreement notified the other of its intent not to renew within the six (6) month period referenced above. Hence, the 1991 Agreement is automatically renewed.

The purpose of this Joint Status Report is to inform the Commission that Clay Electric and PEF are currently discussing the possibility of proposing adjustments to the current Agreement in a joint petition to amend the current Agreement to better facilitate the transfer of customers who are still pending. Clay Electric and PEF anticipate that these discussions will be concluded in the near future and that, if the parties reach agreement on any modifications, the parties thereafter will file a joint petition amending the existing agreement, and requesting Commission approval.
