Dear Mr. Harris:

Staff is in receipt of your application requesting a name change. After reviewing the application, staff identified several deficiencies and contacted you by telephone. In a March 2006, conversation with staff, you stated that all the stock in the utility was transferred over to you from the initial owner which constitutes a change in ownership. Based upon the telephone conversation and the information you provided in your Application for Name Change, it is apparent that you should have filed an Application for Transfer of majority organizational control, as required by Rule 25-30.037(3), Florida Administrative Code, and Section 367.071 Florida Statutes.

I have enclosed a copy of a transfer of majority organization control application. It is important that you complete the application and file it with the commission immediately since the statutes require Commission approval prior to transfer of ownership, or transfer contingent upon commission approval. You should be aware that the transfer of stock without the approval of the Commission or without being contingent upon Commission approval is a violation of Section 367.071, Florida Statutes. Willful violations of the requirements of chapter 367 Florida Statutes may subject you to a penalty or revocation of your certificate as provided by section 367.161 Florida Statutes. Your response to this letter will have an affect upon your application and any determination regarding violations of chapter 367, so please respond in a timely manner.


