RE:	Docket No. 060391-TL – Recommendation to Office of the General Counsel – Petition for expedited review of growth code denials by Number Pooling Administrator for North Naples exchange (North Naples), by Embarq Florida d/b/a Sprint-Florida, Inc.

On May 8, 2006, Embarq Florida d/b/a Sprint-Florida, Inc. (Sprint) filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar), for the North Naples exchange, North Naples (NNPLFLXADS1) switch. Sprint requested a full NXX code to meet a customer's specified request for 500 new DID numbers, that begin with 72, 73, 74, 75, 77, 78, 85, 86, 87. On May 8, 2006, Sprint's request for a full NXX code of numbers was denied because it did not meet the months-to-exhaust utilization criteria required for additional numbering resources.

On May 12, 2006, Sprint filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the Sprint petition and has determined the following:

- 1) The carrier has demonstrated that it has a customer in need of numbering resources;
- 2) The carrier has shown that it is unable to provide services to this potential customer because of NeuStar's denial of the numbering resources; and
- 3) The customer will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.
