**BELLSOUTH'S SECOND MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth") asks the Florida Public Service Commission ("Commission") for an extension of time in which to file executed amendments to its interconnection agreements with the following CLECs: WilTel Local Network f/k/a Williams Local Network, LLC, Level 3 Communications, LLC, LecStar Telecom, Inc., DPI-Teleconnect, LLC, Access Integrated Networks, Inc., Awesome Communications, Inc., Bullseye Telecom, Inc., KingTel, Inc., New Edge Networks, Inc., Southern Telecom, Inc., Supra Telecommunications and Information Systems, Inc., TelWest Communications, LLC and Telephone One Inc. In support of this Motion, BellSouth states the following:

1. Pursuant to Order No. PSC-06-0172-FOF-TP, the parties were required to file executed amendments to the parties' current interconnection agreements or new interconnection agreements on March 10, 2006.

2. On April 17, 2006, the Commission issued Order No. PSC-06-0299-FOF-TP. The Order requires the parties to the Proceeding to file amendments or agreements for issues 5, 13, 16-18 and 22(b) on April 27, 2006.

3. On April 27, 2006, BellSouth filed a Motion for Extension of Time requesting an extension until May 30, 2006 to file executed amendments to the parties' current interconnection agreements.

4. BellSouth and WilTel Local Network f/k/a Williams Local Network, LLC, Level 3 Communications, LLC, LecStar Telecom, Inc., DPI-Teleconnect, LLC, Access Integrated Networks, Inc., Awesome Communications, Inc., Bullseye Telecom, Inc., KingTel, Inc., New Edge Networks, Inc., Southern Telecom, Inc., Supra Telecommunications and Information Systems, Inc., TelWest Communications, LLC and Telephone One Inc. need additional time to incorporate the Commission's Order into the parties' agreements.

5. BellSouth requests that the Commission extend the time to file amendments to its interconnection agreements until June 13, 2006.


6. No party will be prejudiced by this request for an extension as the effective date of the amendments will be March 11, 2006.

7. BellSouth has contacted some but not all of the above-referenced CLECs as to whether they object to the extension. Of the above-referenced CLECs that have responded, none have objected.

WHEREFORE, for the foregoing reasons, BellSouth respectfully requests that this Commission grant it an extension until June 13, 2006 to file amendments in compliance with the Commission's Order in the instant docket.
