Recently the media reported that a transaction of some sort had been entered with Sprint pertaining to Sprint's spin off of their local telephone division. This local labor union represents a number of Sprint employees in matters pertaining to labor relations. Sprint presently has at least one collective bargaining agreement with us detailing the wages, hours and working conditions of a portion of its workers. As such, we have a direct interest in the reported transaction.

As of yet, Sprint has not provided us with a copy of the paperwork pertaining to the spin off transaction and we are greatly concerned that the deal will have a negative impact on Sprint's existing workforce and the public.

Accordingly, I hereby request you to provide me with a copy of all filings of any nature made by Sprint regarding the proposed spinning off their local telephone division, or any other transaction between those corporations. We will be happy to reimburse you for all reasonable charges pertaining thereto. If you cannot provide the documents, please provide the pertinent case numbers so that we can acquire them through other appropriate channels.

Also, I request that you add us to your mailing list regarding any matter pertaining to any transaction between Sprint and the spinning off their local telephone division, and
