#### SSI'S PRELIMINARY LIST OF ISSUES

SOUTHEASTERN SERVICES, INC. ("SSI"), hereby submits this Preliminary List of Issues for the above-referenced consolidated Dockets for the Issue Identification Conference scheduled for Wednesday, June 21, 2006. SSI reserves the right to amend and add to this Preliminary List of Issues through the date of the Issue Identification Conference.

1. <u>The issue referred by the Circuit Court of Baker County</u>: Is Southeastern Services, Inc. legally responsible for payment to Northeast Florida Telephone Company for originating intrastate access charges under Northeast Florida Telephone Company's Florida Public Service Commission-approved tariff for the long distance calls provided by Southeastern Services, Inc.?

2. Were the "long distance calls" that Northeast Florida Telephone Company ("NEFCOM") alleges were made in the pertinent time frame actually Voice Over Internet Protocol services?

3. Did any of NEFCOM's state or federal tariffs in place in the pertinent time frame address Voice Over Internet Protocol services and, if so, what precise provisions were applicable to SSI's Voice Over Internet Protocol services?

4. Were SSI's Voice Over Internet Protocol services provided in the pertinent time frame enhanced and/or information services?

5. Was SSI's traffic at issue jurisdictionally interstate?

6. Was SSI providing an interexchange "telephone toll service" using the PRIs provided by NEFCOM?

7. Was that portion of SSI's traffic that originated in Macclenny and terminated in Jacksonville EAS traffic?

8. Was SSI acting as a CLEC, IXC or end user ESP when it provided the VOIP services in issue?

9. Are any of NEFCOM's claims against SSI time-barred?

10. Did SSI expressly, impliedly or constructively order Feature Group A switched access service from NEFCOM?

11. Did NEFCOM provide Feature Group A switched access service to SSI?

12. Is SSI liable for intrastate originating access charges to NEFCOM for the traffic in issue?

13. If SSI is liable to NEFCOM for intrastate originating access charges on such VoIP services, for what amount is SSI liable?
