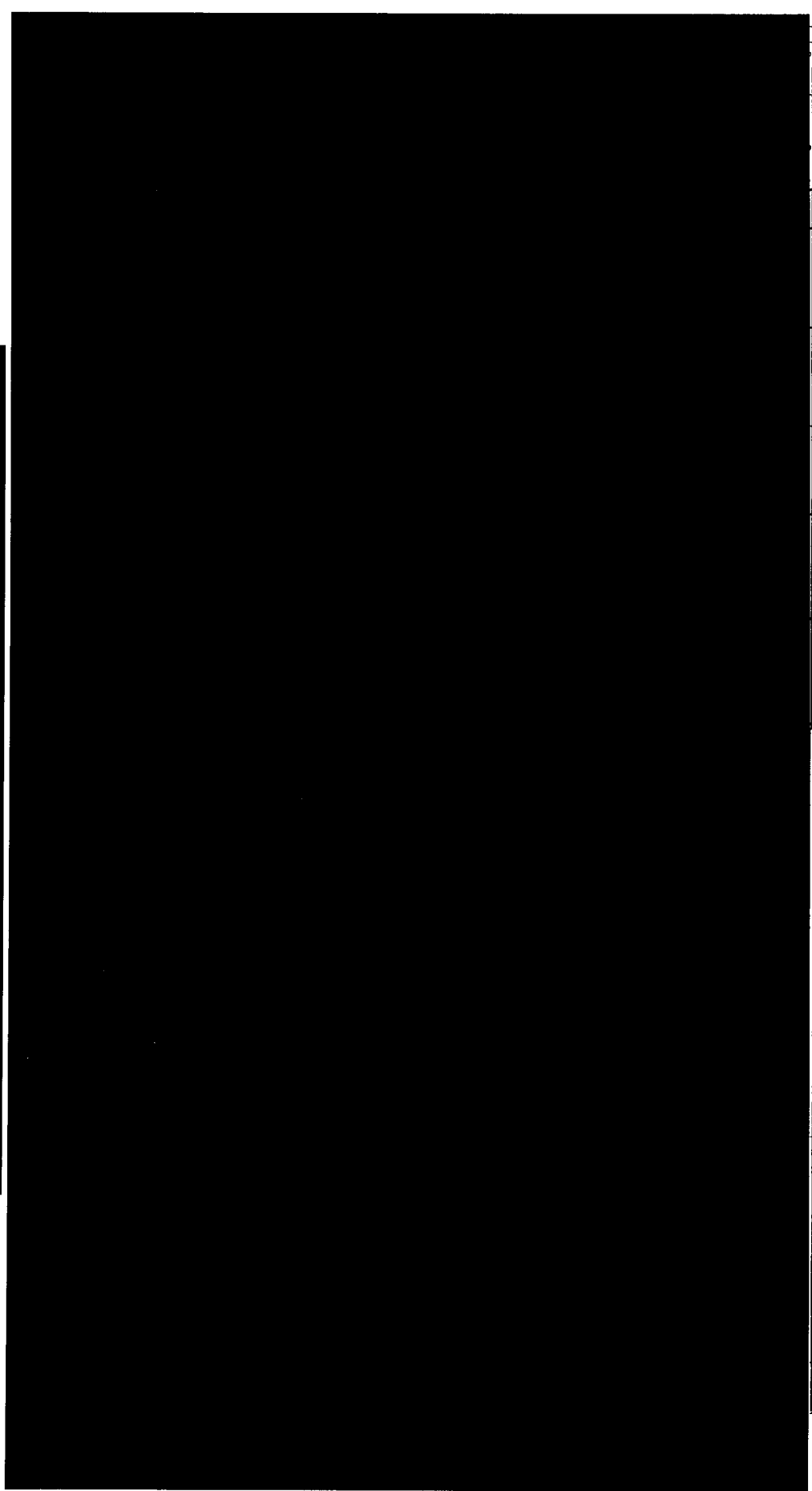

7. Informal Question No. 45

- 45. If a solicitation was issued, what were the requirements of the solicitation, what entities were solicited, what offers were provided, what were the timeframes for the solicitations and responses, what method was used to evaluate the offers if more than one offer was received, and what records exist that documents these solicitation and selection activities?**

As described in the response to Question No. 44, FPL did not issue a public solicitation. FPL contacted five potential providers of natural gas storage and negotiated on a bilateral basis with each potential entity. The process of collecting information on each storage alternative, as well as negotiating potential pricing and terms and conditions extended over a period of approximately six months. FPL evaluated each alternative based on location, withdrawal/injection rates, pipeline interconnections, pricing and term. FPL documented each alternative and the basis for concluding that the MoBay project was the best choice in a presentation made to management as part of the final selection process
