Re: Application for 2006 Price Index Rate Adjustment for Water only in Charlotte County

Dear Mr. Noden:

We have reviewed your application for a Price Index rate adjustment for 2006 received on May 31, 2006, and we find it deficient. At that time, Bocilla's Annual Report for 2005 was not complete. We began our review of your application after Bocilla satisfied the 2005 Annual Report filing requirements on July 25, 2006.

Specifically, we find the following deficiencies:

- (1) Appendix A must be revised to reflect the proper 2005 revenues of \$253,700.
- (2) Appendix B must be revised to reflect the correct 2005 annualized revenues.
- (3) The customer notice must be changed to reflect an October 1, 2006, effective date. In addition, the corrected calculated percentage rate increase must be changed to 1.99%.
- (4) The schedule of proposed rates must be revised to indicate the corrected rates and percentage increases.
- (5) The tariff sheets must be revised to reflect the corrected effective date of October 1, 2006. In addition, the GS and the MS tariff sheets appear to contain errors relating to the tariffed meter sizes. Compared to the present approved tariffs for these rate classes, the proposed tariffs contain a new 3/4" meter and rate, and the tariffed rate for the 8" meter size has been dropped. It appears that these changes are errors, and that the 3/4" size should be eliminated and the rate assigned the 1" meter, and so on through the 8" meter.

If you wish to revise the tariff to add an additional meter size to these tariffs, you must make request to the PSC and receive our approval prior to implementing the new service.
