Surge tank pumps, piping and VFD's

The diurnal flow pattern of the in-season customer base generates two extreme peak flow conditions. The modification of the surge pumps and controls provides a means to reduce the peak flow through the treatment units and thereby maintain adequate plant performance without having to construct additional surge tank capacity.

Survey and Route Selection for Master Lift Station & Force Main

The Utility identified the preferred location and route of the interconnecting force main and master lift station site for the purpose of designing the interconnect with Englewood Water District.

Sanitary Sewer I/I Corrections

The gravity sewer mains made of clay pipe and some manholes in the Sandalhaven Estates subdivision were damaged and allowing large amounts of groundwater to enter the collection system.

Design/Permitting – Sandalhaven WWTP Expansion

Due to customer growth, the Utility investigated various options to expand treatment and disposal capacity sufficient to meet expected growth.

Purchase of 100,000 gpd of Treatment Capacity/EWD

In lieu of expanding the existing plant's treatment and disposal capacity, the Utility reserved 100,000 gpd of treatment and disposal capacity in the Englewood Water District's facilities.

Master Lift Station and Force Main

The Utility is constructing the interconnecting force main and master lift station to convey the majority of the current plant flow and most of the flow generated by future customers to the Englewood Water District's facilities for treatment and disposal through a metered connection.

(b) a copy of all invoices and other support documentation if the plant addition has been completed;

<u>**RESPONSE:</u>** Please refer to Exhibit "1(b)" attached hereto.</u>

- (c) a copy of the signed contract or any bids, if the plant addition has not been completed;
- <u>RESPONSE</u>: <u>Master Lift Station and Force Main</u> Please refer to Exhibit "1c)" attached hereto.
 - (d) a status of the engineering and permitting efforts, if the plant addition has not been through the bidding process; and
- RESPONSE: Master Lift Station and Force Main The engineering design has been completed. Two of three permits to construct the master lift station and force main have been issued by FDEP. The Charlotte County R/W utilization permit has been issued. A permit to directionally drill under Buck Creek is in process. Permit issuance will take an estimated 90 days.

All other plant additions are complete.

(e) the projected in-service date for each outstanding plant addition.

<u>RESPONSE</u>: <u>Master Lift Station and Force Main</u> The estimated completion date is December 31, 2006.

 - (a) Who are the firms or individuals performing the audit services, and what have their hourly rates or lump sum fee been the last four years?
- <u>RESPONSE</u>: PriceWaterhouseCoopers has performed the Utility's audit services for the last four years. The Utility has provided copies of the audit letters for the last four years. Please refer to Exhibit "3(a)" attached hereto. Note that the amounts quoted were exclusive of out-of-pocket expenses.
 - (b) Has the scope of the audit services changed in the last four years? If so, provide the specific changes in the scope of the audit services.
- <u>RESPONSE</u>: The scope of PriceWaterhouseCoopers' audit has not changed. Please refer to Exhibit "3(a)" attached hereto for a description of the scope of the services.
- 4. The following items relate to the utility's requested rate case expense.
 - (a) For each individual person, in each firm providing consulting services to the applicant pertaining to this docket, provide the billing rate, and an itemized description of work performed. Please provide detail of hours worked associated with each activity. Also, provide a description and associated cost for all expenses incurred to date.

5. In Schedule F-6, Used and Useful calculations

The utility stated that "In October 2005, Sandalhaven signed an agreement with the Englewood Water District (EWD) to purchase 100,000 gallons per day wastewater treatment & disposal service. To accommodate this agreement will require Sandalhaven to construct approximately 3.5 miles of 10" and 12" force mains to interconnect with EWD and to reroute flows from existing customers and serve the additional customers. Until the interconnection is activated Sandalhaven will continue to utilize the existing plant."

(a) Please provide a copy of the signed agreement with the EWD.

RESPONSE: Please refer to Exhibit "5" attached hereto.

(b) Has the utility interconnected the wastewater treatment plant (WWTP) with EWD?

<u>**RESPONSE</u>**: No, the force main is currently under construction.</u>

- (c) If yes, when was the date of interconnection? If no, when will the utility interconnect with EWD?
- <u>**RESPONSE</u>**: The interconnection is scheduled to be completed before December 31, 2006.</u>
 - (d) If the utility is interconnecting with EWD, please provide an explanation as to why the utility has a cost for a design/permitting fee in the amount of \$540,335, for Sandalhaven WWTP expansion project.
- <u>RESPONSE</u>: The design/permitting fee in the amount of \$540,335 reflects the initial engineering services contract to design, permit, and inspect construction of a new treatment plant and deep injection well for disposal. Subsequently, the contract was cancelled once the decision was made to construct an interconnection with EWD. A proforma adjustment should be made to reflect the investment that occurred prior to cancelling the engineering contract.
 - (e) Does the utility plan to retire the entire WWTP after interconnection with EWD?
- <u>RESPONSE</u>: The WWTP will remain in service until such time as the collection system in the northern portion is modified so that the flow generated by customers in that part of the system can be pumped into the interconnecting force main with EWD.
 - (f) If yes, when will the utility retire the entire WWTP?
- <u>RESPONSE</u>: The retirement date is dependent on the timing of the redevelopment of the Wildflower Golf Course as a residential community.

- (g) If the utility does not plan to retire the entire plant in the near future, please provide the following information:
 - 1. How many gallons of water were sold to the residential customers during the test year?
- <u>RESPONSE</u>: The Utility is not certain what the Staff means by "near future." The date of retirement of the WWTP depends on a number of factors which are not within

the control of the Utility, such as the timing of the redevelopment of the Wildflower Golf Course.

However, the gallons sold to residential customers during the test year capped at 8,000 gallons, was 17,793,000 gallons. This was determined from MFR Schedule E-2, page 4 of 6. This information was provided as a part of the Infiltration & Inflow analysis at line 8, which was submitted in response to MFR Deficiency No. 7.

- 2. How many gallons of water were sold to the general service customers during the test year?
- <u>RESPONSE</u>: The Utility is not certain what the Staff means by "near future." The date of retirement of the WWTP depends on a number of factors which are not within the control of the Utility, such as the timing of the redevelopment of the Wildflower Golf Course.

However, the gallons sold to general service customers during the test year was 7,766,000 gallons. This was also determined from the MFR Schedule E-2, page 4 of 6. This information is found at line 9 of the previously referenced Infiltration & Inflow analysis, in the billing analysis (Schedule E-14 of the MFR).

3. What is the size and length of the collection lines? (Example: 8" pipe - 3500 ft.)

<u>RESPONSE</u>: The collection lines consist of 8" pipe, and the length is 29,863 linear feet.

6. Schedule F-8, Margin Reserve Calculations

The instructions for this schedule require the utility to provide all calculations and analyses used to determine the amount of margin reserve for each portion of used and useful plant. None of the components have been provided. Please provide all supporting calculations for the components reflected on this schedule with the exception of post test year period per statute.

<u>RESPONSE</u>: The utility respectfully takes exception to the statement that none of the [calculation and analyses] components have been provided. The references with each component guide one to the basis for each calculation. In the interest of clarity, the response below further explains those calculations and analyses.

The 1st component as stated in F-8 is:

EG = Equivalent annual growth in ERCs (see F-10) 202 ERC/yr

The component references Schedule F-10. F-10 states "The historical trend in growth of 40 ERCs per year is not indicative of growth for the next several years. Developers have indicated the expectation that [the] following additional units will be completed by the end of 2008:

Hacienda Del Mar – 112 condo units; Hammocks @ Cape Haze – 234 condo units; Cape Haze Resort – 242 units; Placida – 422 units. The total is 1,010 units. This will essentially double the customer base in 3-5 years. Assuming a conservative 5 year buildout, the annual rate is 202 units per year."

The 2^{nd} component as stated in F-8 is:

U = Unit of measure utilized in U&U calculations 95 gpd/ERC* * TY AADF (Schedule F-4) divided by TY ERCs (Schedule F-10)

Wherein: U = 97,367 AADF (from F-4)/1,026 ERCs (from F-10) = 95 gpd/ERC

The 3rd component as stated in F-8 is:

PN = Property needed expressed in U units

95,846 gpd

This is not actually a component, but a formula for combining the components into the final result of property needed (otherwise referred to as margin reserve). PN is defined in the PSC rules and restated on F-8 as EG x PT x U, where PT is the statutory 5 year post test year period.

Wherein: $PN = 202 \times 5 \times 95 = 95,846 \text{ gpd}$

Finally, there is a statement that the PN, as limited by the maximum statutory growth rate of 5% per year, is 24,342 gpd. It is true that this was not supported by a reference, but it is simply 5% of the TY AADF from Schedule F-4 times 5 years or: $5\% \times 97,367 \times 5 = 24,342$ gpd.

7. Schedule E-10, Service Availability Charges

Since the utility is requesting new and revised service availability charges, staff needs additional information.

(a) For the December 31, 2005 test year, please provide the information required pursuant to Rule 25-30.564(4)(a) through (u), Florida Administrative Code.

<u>RESPONSE</u>: The information is being collected and will be provided when it is available.

- (b) Since a system capacity charge is designed to defray a portion of the cost of the plant, as well as a portion of the cost of lines, why is the utility requesting a system capacity charge when they already have a plant capacity charge for which they are requesting an increase in (*sic*)?
- <u>RESPONSE</u>: A revised system capacity charge needs to reflect the Utility's payment of capacity fees paid to EWD as well as the investment in the collection system improvements necessary to convey wastewater to EWD.
 - (c) Since the utility has an existing plant capacity charge and is requesting a main extension charge which is equal to the total actual cost incurred, why is the utility requesting a system capacity charge?

- <u>RESPONSE</u>: The Utility must make two separate investments. The first is to reserve capacity in EWD's treatment and disposal systems. The second is to construct the interconnecting pipeline.
- 8. Schedule B-8, Comparative O&M Expenses Sewer

Staff requests the following information related to purchase sewage treatment and purchase chemicals.

- (a) The utility states the purchase sewage treatment increased since the last rate case because the utility hauled sewage to another treatment plant during an emergency condition. Was this emergency condition a hurricane or thunderstorm? If not please state what the emergency condition was. Does the utility consider this emergency a reoccurring or nonrecurring expense?
- <u>RESPONSE</u>: This emergency was related to the impact of Hurricane Wilma. The Utility considers this a prudent and necessary expense. It would be speculative to state that this expense is nonrecurring since other causes may dictate the need to use similar means to address problems with plant or collection system operations
 - (b) Sandalhaven stated that the chemicals increased above inflation and growth since the last rate case because they (*sic*) converted their (*sic*) disinfection system to sodium hypochlorite. Why was it necessary to convert to the new disinfection system? If the reason for the conversion was mandated by Florida Department of Environmental Protection (FDEP), please provide all documentations (*sic*) where the FDEP mandated this conversion.
- <u>RESPONSE</u>: By removing pressurized chlorine gas cylinders from the wastewater plant site, the Utility reduced the risk of a toxic release of the chemical. Customers' homes are located in close proximity to the site. The customers, visitors, and utility personnel benefit from having sodium hypochlorite stored on site instead of chlorine gas because a liquid is inherently easier and safer to transport, store and use than compressed gas.

2) an 8" force main along the County Road 775 right-of-way (ROW) from the proposed master lift station to Gasparilla Pines Blvd.

3) a 10" force main from Gasparilla Pines Blvd. to the Englewood Water District WWTP.

4) a flow meter, meter vault, and associated materials.

The design/partnership approach has been chosen in order to expedite the completion of the project in a short time frame. The force main will be 3.5 to 4 miles long, depending on the final route location, which will be determined separately under WO#3948.

Justification & Benefits

Growth within the service area has increased more rapidly than anticipated. In order to meet contractual commitments to developers in the short-term, a bulk wastewater agreement was entered into with the Englewood Water District in lieu of expanding the Sandalhaven WWTP's permitted capacity and constructing a Deep Injection Well at an estimated cost of \$6 million. The proposed project includes the design and construction of the master lift station and force main to deliver flow to Englewood's WWTP for treatment and disposal through a metered connection. The facilities will be designed to handle total build-out flow conditions in the Sandalhaven service area.

This project needs to be completed by November, 2006 in order to meet contractual obligations with the developer of The Hammocks at Cape Haze. The surveying and route selection process have been approved under WO#3948 and are underway. The engineering, permitting and construction of the master LS and FM are being combined in this WO to minimize the timeline and meet the November deadline. Multiple design firms were solicited to provide their methodology to complete this project in the timeframe required. Only two firms were willing to provide a proposal for the project; CH2M Hill and CPH. Both firms proposed streamlining the traditional process and utilize a design/build or design/partnership approach to save time. Each one provided a firm bid for engineering design and permitting costs and an estimate for the construction of the project. CPH's design fees were 25% of CH2M Hill's but both firms were estimating over \$3.3 million for construction due to the uncertainty of the route, the requirement by the county to drill verses open cut the ROW along most of the route and the compressed schedule limiting the availability of contractors. CPH was chosen given their lower design fees and their commitment of resources and contractor availability to complete the project by the required deadline. Preliminary discussions with the contractor indicate that his unit prices will be competitive with other jobs he has done for us. So, the original estimate from the eingineer was reduced to \$2.8 m for this WO. Once approved, they will lock down the prefered contractor and get a firm price to be used in a "cost plue" contract for materials and a fived unit labor cost

Growth projections for this system indicate that flows will exceed the permitted plant capacity in early 2007. The WWTP expansion will not be completed until early 2008. The existing WWTP cannot accommodate the proposed additional flows. The monthly DMRs submitted to FDEP identify the remaining unused capacity. DEP potentially could take enforcement action, including levying fines against the Utility.

2. USE CONVENTIONAL BIDDING TECHNIQUES

Due to the time required to bid out design and construction services sequentially, this would not allow the timely completion of this project before flows exceed plant capacity. By utilizing the design/partnership concept, this time frame is reduced thus allowing for a shorter project duration. The cost for a design/partnership concept will cost approximately the same as the conventional design-bid-build process assuming that the contractor is locked into a unit price for labor, the material quantities are identified up front, and materials are billed on a cost plus basis. Based on discussions with the design engineer and our preferred contractor, the major unknowns are wet weather, storm events, underground conflicts, and limerock that would require additional materials and labor and cause time delays. Based on recent bid prices in the area and after talking with the preferred contractor, the unit price for open cutting 8" and 10" pipe is about \$60/LF. Necessary directional drilling and dewatering elements of this project increased the estimated the unit price to \$100/LF or an estimated FM cost of over \$2 million plus \$0.5 million for the LS &

The force main is leaking inside the wet well and spraying sewage at a high force against the concrete walls of the wet well and is compromising the integrity of the concrete structure. Lift station #4 receives sewage from two other lift stations and if the force main fails completely there will be no avenue to pump sewage from three lift stations.

Until the repairs are completed, the pumps will cycle on and off more frequently causing an increase in power consumption.

Alternatives

1. DO NOT MAKE THE REPAIR: This alternative will result in the complete collapse of the force main and sewage from three lift stations will have to be transported by vac trucks to the plant.

2. INSTALL A PIPE REPAIR CLAMP AT THE BREAK IN THE FORCE MAIN: The force main is several years old and a new section of pipe approximately ten to twenty feet long needs to be installed. The location and orientation of the pipe break necessitates pipe replacement, not simply installing a repair clamp.

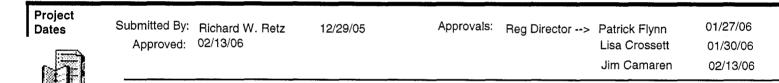

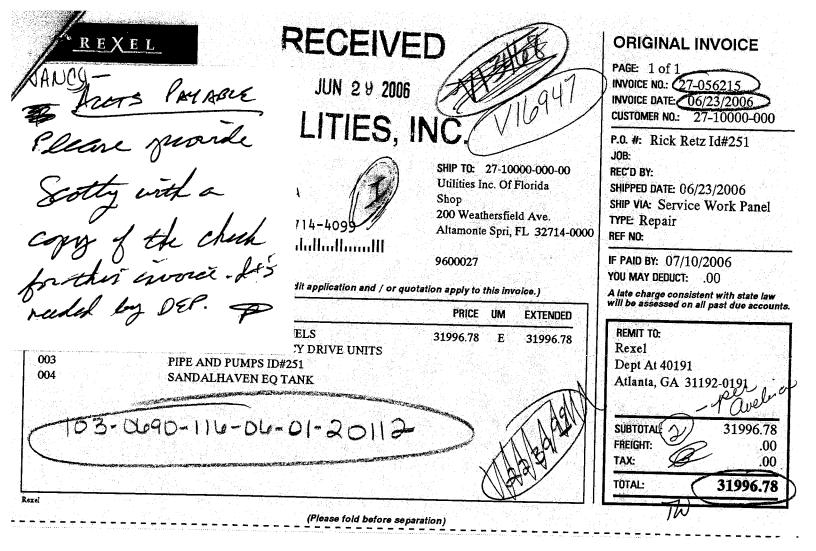

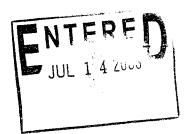

In order to expedite the construction of this critical force main, the survey and route selection components were broken out and will be authorized separate from the design, permitting and construction components. Description

Perform repairs to defective sewer mains discovered during an infiltration/inflow (I/I) evaluation of the sanitary sewer system. This area has a high groundwater table due to its proximity to the Gulf of Mexico. The video inspection identified areas that need repairs to reduce I/I by approximately 10,000 gal/day.

Location

Sandalhaven collection system, Gasparilla Pines Blvd and multiple feeder road intersections, Placida, Charlotte County, Florida

Justification & Benefits

Approximately 20,000 linear feet (LF) of 8" PVC and vitreous clay sanitary sewer piping was videotaped to locate the source of infiltration problems. The survey area included the oldest sections of the Sandalhaven collection system along Gasparilla Pines Blvd. and Sandalhaven Estates subdivision. With the ongoing WWTP expansion delayed and the plant already near its capacity in the seasonal months, every effort to reduce flow into the existing plant will be beneficial.

The video inspection identified multiple areas that need repairs to reduce infiltration. Methods of repair to be used include chemical grouting, sectional lining and complete manhole to manhole lining, depending on the severity of damage to the pipe.

Lining these damaged sections of pipe will restore pipe integrity, reduce groundwater infiltration, reduce the possibility of future pipe failure and will provide a seamless repair that does not require excavation. Since these repairs will utilize trenchless methods, customer inconvenience and restoration costs will be minimized.

Reducing groundwater infiltration will lower treatment costs and ease some of the burden attributed to increasing flows at the WWTP while the plant expansion is taking place.

Alternatives

1. EXCAVATE AND INSTALL NEW GRAVITY MAINS

This alternative is not recommended because of the enormous restoration and construction costs. Dewatering throughout the project would also be required because of the high groundwater table.

2. PIPE BURST LINE SEGMENTS IN NEED OF REPAIR

This alternative is more costly than the trenchless repair methods selected. This method also would require extensive restoration costs due to the excavation required to reestablish the service connections.

3. INSTALL CIPP LINERS IN MULTIPLE PHASES

This alternative would ultimately be more costly due to the mobilization charges for each phase of the project. It is more cost effective to perform the repairs in one phase.

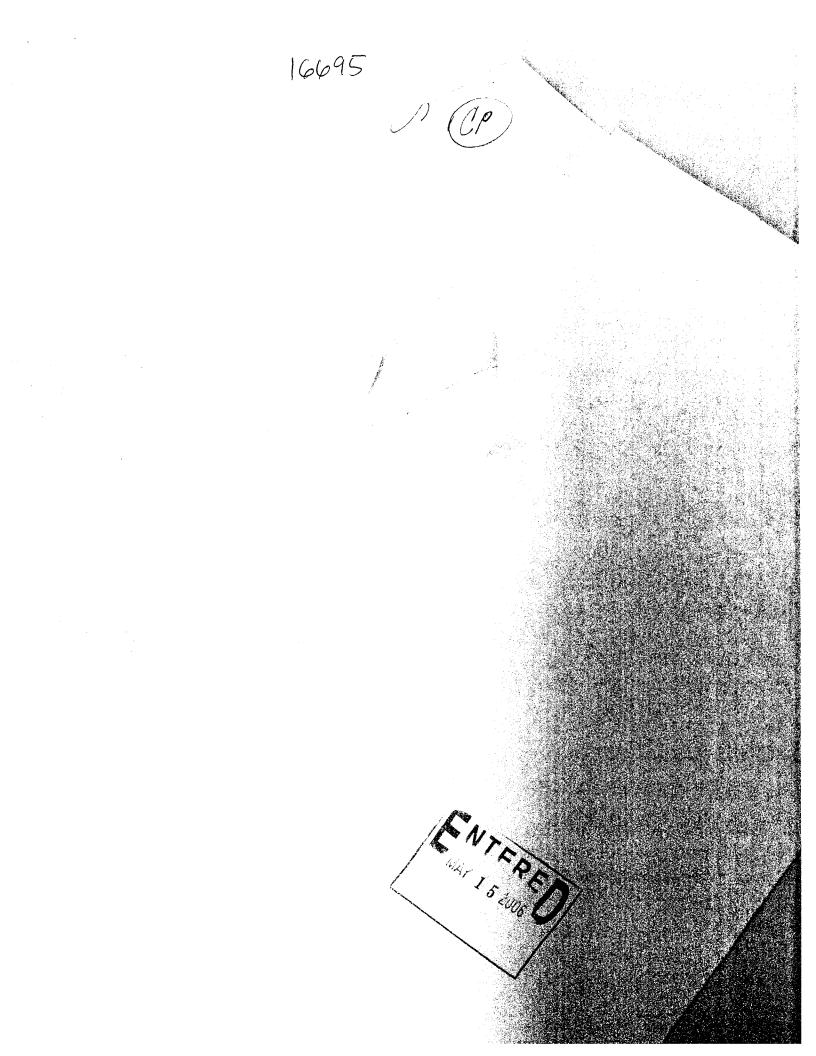

This project has been cancelled due to the management decision to pursue and interconnect with Englewood Water District. The work order for the actual construction of the plant expansion has already been deleted from the capital database. TW 4/20/06.

The recommended alternative for the plant expansion from the Consultant was to construct an interconnect with the Englewood Water District (EWD) for effluent disposal. In a meeting held with EWD, we were informed they would only accept raw influent. Sending raw influent to EWD was not acceptable to upper management due to the loss of control of the system that would make it vulnerable to a possible take over and the payment of \$7.5M in impact fees for 1MGD of plant capacity. Other options needed to be explored for effluent disposal.

A Shallow Well was not recommended by FDEP because of extensive permitting requirements and the probability that a confining zone for a shallow well would not be present in the Sandalhaven area. Ponds are not an option due to the insufficient land available in this area for effluent disposal.

The only option left was to expand the wastewater treatment plant and drill a Deep Injection Well (DIW) for effluent disposal. Engineering design for a DIW was not part of the original design proposal. The following are the tasks and costs associated with the design of the DIW:

Project Description

Purchase of the first 100,000 gpd of wastewater treatment and disposal capacity from Englewood Water District.



Location

Sandalhaven WWTP, 6811 Placida Road, Englewood, Charlotte County, Florida

Justification & Benefits

Provide additional capacity so as to serve new developments. Growth within the service area has increased rapidly. In order to meet contractual commitments to developers in the short-term, a bulk wastewater agreement was entered into with the Englewood Water District in lieu of expanding the Sandalhaven WWTP and constructing a Deep Injection Well at an estimated cost of \$6 million. This WO represents the purchase of the first 100,000 gpd from EWD with the intent of purchasing another 400,000 gpd within the next 24 months. The design and construction of a master lift station and force main to deliver flow to EWD's WWTP for treatment and disposal is described under WO #3875.

The surveying and route selection process has been approved under WO# 3948 and is under way. The engineering, permitting and construction of the master LS and FM is combined in WO# 3875 and has been submitted for approval. This proposed treatment capacity purchase is necessary to reserve capacity in Englewood's WWTP, allowing the Sandalhaven WWTP either to be taken offline and decommissioned or remain in service for a period of time at reduced flow. Taking the plant out of service depends on the timing of the redevelopment of the Wildflower Country Club and the resulting loss of effluent disposal capacity.

Alternatives

1. DO NOT PURCHASE THE TREATMENT AND DISPOSAL CAPACITY

This would cause the existing 150,000 gpd Sandalhaven WWTP to be overloaded once additional customer growth occurs. Current AADF = 0.100 mgd and max month average day flow = 0.125 mgd. Commitments to serve projects in the southern portion of the service territory exceed 0.100 mgd. A master lift station and force main are being designed to accommodate treatment and disposal requirements of the service territory at build out. The purchase of this treatment capacity from EWD will augment Sandalhaven capacity initially as well as provide for the eventual shutdown of the Sandalhaven WWTP. 2. PURCHASE MORE THAN 100,000 GPD OF CAPACITY.

Based on the 2005 master sewer plan, system build out flow will be as much as 1 mgd. However, the total capacity required to serve Sandalhaven's current and future customers over the next five years is less than 0.500 mgd. An agreement with EWD to purchase 0.200 mgd of capacity in February 2007 and an additional 0.200 mgd in February 2008 will provide suficient capacity to meet customer growth in the near term. EWD has agreed to sell capacity in increments and is willing to adjust its plant expansion program accordingly.

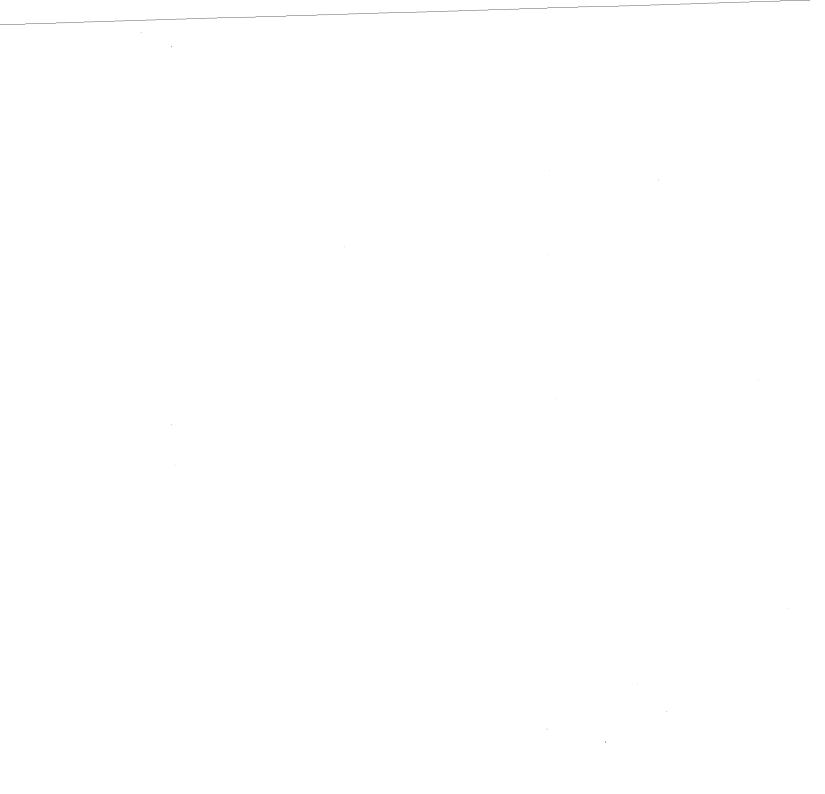

AMENDMENT TO BULK WASTEWATER AGREEMENT

THIS AMENDMENT to Bulk Wastewater Agreement is made and entered into this _____ day of ______, 2006, by and between ENGLEWOOD WATER DISTRICT, having its principal place of business at 201 Selma Avenue, Englewood, FL 34223 ("District"), and UTILITIES, INC. OF SANDALHAVEN, having its principal place of business at 200 Weathersfield Avenue, Altamonte Springs, FL 32714 ("Utility").

WITNESSETH

WHEREAS, District and Utility entered into a Bulk Wastewater Agreement dated October 6, 2005 ("Agreement"), whereby Utility obtained 100,000 gallons per day of wastewater treatment capacity from District; and

WHEREAS, Utility desires to obtain additional wastewater treatment capacity, and District is willing and able to provide such additional treatment capacity.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, it is mutually agreed by and between the parties as follows:

1. Paragraph 1 of the Agreement is hereby deleted, and shall provide as follows:

Utility shall pay to District treatment plant capital capacity charges in the amount of \$3,761,863.15 for 500,000 GPD of treatment capacity. Such charges shall be payable as follows:

- (a) \$752,372.63 on or before April 4, 2006.
- (b) \$1,504,745.26 on or before February 15, 2007.
- (c) \$1,504,745.26 on or before February 15, 2008.

If any such payments are not made by the due date, then the District's obligation to provide wastewater service for any capacity in excess of that paid for may terminate at the discretion of the District.

2. Except as amended hereby, the District and Utility hereby reaffirm the provisions of the Agreement.

IN WITNESS WHEREOF, ENGLEWOOD WATER DISTRICT and UTILITIES, INC. OF SANDALHAVEN have caused this Amendment to Bulk Wastewater Agreement to be duly executed and entered into on the day and year first above written.

BULK WASTEWATER AGREEMENT

THIS AGREEMENT, made and entered into this <u>b</u> day of <u>October</u>, 2005, by and between the Englewood Water District, having its principal place of business at 201 Selma Avenue, Englewood, Sarasota County, Florida 34223 ("DISTRICT") and Utilities, Inc. of Sandalhaven, having its principal place of business at 200 Weatherfield Avenue, Altamonte Springs, Florida 32714 ("UTILITY");

WITNESSETH:

WHEREAS, DISTRICT is an independent special district of the State of Florida with the authority to provide wastewater service within and without its boundaries; pursuant to Chapter 2004-439 Laws of Florida; and

WHEREAS, UTILITY is a Florida for profit corporation with full power and authority to enter into this Agreement, to carry out the transactions contemplated hereunder, and to carry out its obligations hereunder; and

WHEREAS, DISTRICT currently has a 3.0 MGD Water Reclamation Facility with available treatment and disposal capacity; and

WHEREAS, UTILITY desires to obtain 100,000 gallons per day of treatment capacity within DISTRICT'S Water Reclamation Facility and further desires to obtain monthly treatment service as a bulk wastewater customer at the established bulk wastewater treatment rate.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, it is mutually agreed by and between the parties hereto as follows:

1. UTILITY shall pay to DISTRICT treatment plant capital capacity charges in the amount of \$752,372.63 for 100,000 GPD of treatment capacity. The treatment plant capital capacity charge shall be due and payable prior to any service being provided. If such sums are not paid to DISTRICT by UTILITY within 180 days from the date of this Agreement, either party may terminate this Agreement.

2. UTILITY shall be responsible for design, permitting (including any required modification of DISTRICT'S operating permit), and construction of any wastewater system(s), including all sewer lines, lift stations, and other facilities and appurtenances (exclusive of providing a bulk wastewater meter) that may be necessary in order to connect to and operate DISTRICT'S wastewater system in accordance with this Agreement.

3. UTILITY shall be responsible to conduct all investigations and testing as may be required in order for UTILITY to connect to DISTRICT'S wastewater system. UTILITY shall be responsible for acquiring all easements and rights of way necessary in order to connect UTILITY'S wastewater system to DISTRICT'S wastewater system at the designated Point of Connection. The Point of Connection of UTILITY'S wastewater system to DISTRICT'S wastewater system shall be designated by DISTRICT in its sole discretion.

4. UTILITY shall construct all wastewater systems pursuant to the terms of this Agreement and DISTRICT'S standards. UTILITY shall submit all drawings and specifications to DISTRICT for approval prior to submittal to the Department of Environmental Protection.

5. Any portion of the transmission systems constructed by UTILITY pursuant to this Agreement within the geographic boundary of the DISTRICT shall be conveyed with associated easements to DISTRICT after Department of Environment Protection certification of completion and prior to any service being provided by DISTRICT per terms of this Agreement. DISTRICT, at its own expense, shall install an appropriate metering device at a location determined by DISTRICT for the purpose of determining the amount of monthly wastewater service being provided.

6. Upon UTILITY connecting its wastewater system to DISTRICT's wastewater system, DISTRICT shall use reasonable diligence to provide continuously bulk wastewater treatment and disposal services to UTILITY within the purchased capacity established by this Agreement. DISTRICT shall not be liable to UTILITY for any interruption of service. In the event UTILITY desires to divert flow to DISTRICT for limited periods in excess of the capacity established by this Agreement, DISTRICT will make its best efforts to accommodate the excess flow, but does not guarantee the availability of capacity in excess of that provided herein. If the Annual Average Daily Flow (AADF) for any 12 month period exceeds the purchased treatment capacity herein, additional capacity charges will be due and payable to DISTRICT up to the AADF capacity at the applicable rates at the time of purchase if capacity is available in the Water Reclamation Facility.

7. UTILITY shall not discharge or cause to be discharged any waste that may be harmful to DISTRICT'S wastewater systems to include but not limited to: excessive storm water or ground water; wastewater containing toxic, poisonous, pathogenic, explosive or flammable substances; wastewater with a ph lower than 5.5 or higher than 9.5 or a temperature greater than 150 degree Fahrenheit; or other wastewaters that may create a hazard in the received waters of the Water Reclamation Facility. The maximum allowable values for certain materials in, or characteristics of wastewater measured at the point of entry into UTILITY'S collection system shall be governed by standards of the USEPA, FDEP and the Water Pollution Control Federation. DISTRICT reserves the right to refuse waste from any source which may, in the sole judgment of DISTRICT, harm the Water Reclamation Facility or create a hazardous situation. If UTILITY fails to comply with this provision after 90 days' written notice to UTILITY of its violation of this provision, this Agreement may be terminated by DISTRICT.

8. The current DISTRICT Bulk wastewater treatment rate is \$7.28 per 1,000 gallons of metered wastewater flow. There is no monthly base charge for availability. The bulk wastewater treatment rate for all bulk customers is subject to change from time to time consistent with DISTRICT Customer Rules and Regulations.

9. UTILITY shall pay DISTRICT'S monthly invoice for bulk wastewater treatment within thirty (30) days after receipt. In the event that payment is not made within thirty (30) days after receipt of the invoice, UTILITY agrees to pay interest at a rate of one and one-half percent (1.5%) per month on the outstanding balance until paid in full.

10. This Agreement shall be governed by and construed in accordance with

the laws of the State of Florida. The parties expressly consent to the jurisdiction of and agree to suit in any court of general jurisdiction in the State of Florida, whether state, local or federal, and further agree that venue shall lie in Charlotte County, Florida.

11. A breach of this Agreement shall mean a material failure to comply with any of the provisions of this Agreement. If any party breaches any obligation herein, then, upon receipt of written notice by the non-breaching party, the breaching party shall proceed diligently and in good faith to take all reasonable actions to cure such breach and shall continue to take all such actions until such breach is cured. If either party breaches this Agreement, the injured party may seek damages or specific performance to the extent allowed by law; however, neither party waives its rights, privileges, or immunities. Notwithstanding the foregoing, DISTRICT shall not be deemed to be in breach of this Agreement for any interruption in service.

12. All notices, certificates, or other communications hereunder shall be sufficiently given and shall be deemed given when hand delivered or mailed by registered or certified mail, postage prepaid, to the parties at the following addressed:

13. The parties may, by notice in writing given to the other, designate any future or different addresses to which the subsequent notices, certificates, or other communications shall be sent. Any such notice shall be deemed given on the date such notice is delivered by hand or by facsimile transmission or five (5) days after the date mailed.

14. No amendment, appendix, supplement, modification or waiver of this Agreement shall be binding unless executed in writing by all parties hereto.

15. In the event that the performance of this Contract is prevented or interrupted in consequence of any cause beyond the control of DISTRICT, including but not limited to, Acts of God or of a public enemy, war, national emergency, allocation of or other governmental restrictions upon the use or availability of labor or materials, rationing, civil insurrection, riot, civil rights disorder or demonstration, strike, embargo, flood, tidal wave, fire, explosion, bomb detonation, nuclear fallout, windstorm, hurricane, earthquake, or other casualty or disaster or catastrophe, unforeseeable failure or breakdown

of pumping transmission or other facilities, and all governmental rules or acts or orders or restrictions or regulation or requirements, acts or action of any government or public or governmental authority or commission or board or agency or agent or official or officer, the enactment of any statute or ordinance or resolution or regulation by governmental entities having jurisdiction, over the operation of DISTRICT or otherwise having valid legal jurisdiction, excluding any acts or rules or regulations adopted by DISTRICT, or rule or ruling or order, order or decree or judgement or restraining order or injunction of any court, said party shall not be liable for such non-performance.

16. It is agreed by and between the parties hereto that all words, terms, and conditions herein contained are to be read in concert, each with the other, and that a provision contained under one heading may be considered to be equally applicable under another heading in the interpretation of this Agreement.

17. This Agreement is solely for the benefit of the parties hereto and no other causes of action upon, or hereof, is to or for the benefit of any third party, who or which is not a formal party hereto.

18. The Englewood Water District Customer Rules and Regulations ("Rules"), which are subject to revision from time to time, are incorporated into this Agreement by reference. This Agreement will control should there be any conflict between this Agreement and the Rules. However, any amendments to the Rules shall automatically be incorporated herein.

19. UTILITY agrees to indemnify and hold DISTRICT harmless from and against any and all liabilities, claims, damages, costs, and expenses (including reasonable attorney fees) to which DISTRICT may become subject by reason of or arising out of this Agreement. Nothing herein shall constitute a waiver of sovereign immunity pursuant to state law.

20. This Agreement shall be binding upon and shall inure to the benefit of the successors or assigns of the parties hereto.

21. This Agreement is the entire agreement between the parties pertaining to the subject matter hereof, and supersedes all prior and contemporaneous agreements, understanding, negotiations, and discussions of the agreements, understanding, negotiations, and discussions of the parties, whether oral or written, and there are not warranties, representations or other agreements between the parties in connection with the subject matter hereof, except as specifically set forth herein.
