JOINT MOTION FOR EXTENSION OF TIME

By Order issued June 27, 2006, the Commission granted the joint motion of MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services ("Verizon Access") and BellSouth Telecommunications, Inc. ("BellSouth") (collectively, the "Parties") for an extension of time to file post-hearing briefs until August 4, 2006. The Parties jointly move for the Commission to postpone any additional activity in this arbitration proceeding. The Parties request the postponement because they believe they have reached agreement on the resolution of all outstanding arbitration issues. With the exception of the dismissal of the pending arbitration petition, the Parties' expectation is that no further arbitration-related activity will be necessary once the Parties' interconnection agreement is finalized; any and all necessary corporate approvals have been obtained; and the interconnection agreement has been submitted to and approved by the Commission.


WHEREFORE, BellSouth and Verizon Access respectfully request that their joint motion be granted.
