**NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida, Inc., ("PEF" or "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of confidential portions of Exhibit No. __ (JP-1P) to the direct testimony of Javier Portuondo and Exhibit No. __ (JM-1P) to the direct testimony of Joseph McCallister dated September 1, 2006.

Specifically, Exhibit No. __ (JP-1P), Section C, page 3 of 5, contains sensitive business information concerning power purchases; and Exhibit No. __ (JM-1P), page 6 of Risk Management Plan, contains sensitive business information concerning contract terms, the disclosure of which would impair the efforts of the Company to negotiate contracts on favorable terms. If persons or energy suppliers were allowed to obtain the information at issue, they could discern sensitive information which could lead to adverse effects for the Company in future contract negotiations.

Attached as Exhibit A is a confidential, highlighted copy of the above referenced documents.

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of filing this request.
