

This notice is being provided to you since you have previously inquired about receiving water service from Blue Heron Golf & Country Club.

On August 14, 2004, Blue Heron Golf & Country Club (*Utility*), filed its application to the Florida Public Service Commission (*Commission*) for grandfather certificate to operate water utility in Okeechobee County.

At its regularly scheduled Agenda Conference held on June 20, 2006, the Florida Public Service Commission took action on the Utility's application. By Order No. PSC-06-0595-FAA-WU, issued July 7, 2006, the Commission granted Blue Heron Golf & Country Club a water certificate and authorized the Utility to collect a plant capacity charge of \$400.00 for each new single-family residence that connects to the Utility's water system. This charge is in lieu of the \$1,200.00 system capacity charge previously imposed on new connections.

The meter installation fee remains at \$150.00.

This plant capacity charge approved by the Commission will be effective for service on or after August, 1, 2006.
