



Application for a Staff-Assisted Rate Case in Pasco County by Holiday Utility Company, Inc.

DOCKET NO. 041145-WU

On December 7, 2004, Holiday Utility Company, Inc. (Holiday or utility) filed an application for a staff-assisted rate case with the Florida Public Service Commission (PSC). Holiday, a water utility operating in Pasco County, provides service to approximately 334 customers. The utility's service area is located west of U.S. 19 near Holiday, in Pasco County.

The current rate case is being processed under the PSC's "Proposed Agency Action" (PAA) procedure. Under the PAA process, the case will not be set for a formal hearing unless a timely protest to the Commission's proposed agency action is filed.


As part of the process of evaluating Holiday's request, the PSC staff conducts a customer meeting to allow customers the opportunity to provide input into the rate setting process. Customer comments are an integral part of the process and will assist the Commissioners in reaching their decision.

The utility's records have been audited by PSC staff for compliance with the applicable rules and orders. In addition, a PSC staff engineer has conducted a field investigation of the utility's plant and service area. In accordance with Florida Statutes, the PSC will consider

the utility's quality of service and other matters in this case.

According to PSC staff's preliminary analysis, average residential consumption is 4,353 gallons. At present, the average monthly bill is \$11.29 for residential customers. The average monthly bill using staff's preliminary proposed rates would be \$15.84 (base facility charge plus gallonage charge). Information obtained at the customer meeting will be incorporated into staff's recommendation to the Commission.

PSC staff is scheduled to file a recommendation to the Commission on April 21, 2005. The Commissioners are expected to vote on this matter at the May 3, 2005, Agenda Conference.




