The parties report that the remaining issues identified in both phases of the Generic Hot Cut Docket (FPSC Docket No. 041338-TP) have been resolved, are currently under resolution or have been withdrawn. The parties agree to the closing of FPSC Docket No. 041338-TP.

This letter of agreement between CLECs and BellSouth comes with BellSouth's commitment to continue collaborating with CLECs in the resolution of any implementation issues that may arise regarding the issues presented in the docket. Further, the parties agree that the dismissal of the docket cannot be used as a defense against any claim a party might bring in a subsequent proceeding regarding matters not resolved by the hot cut settlement agreement or the implementation referred to above or BellSouth's disconnect fees; however, the parties retain any other available defense to such a proceeding.
